## Section A: Overview of Release

### A1. Payroll System

#### A1.1. Calendar Year 2024 Georgia Health Insurance (GHI) Employee Premiums

These instructions contain all of the information necessary to import the Department of Community Health (DCH) open enrollments, to set the employee deductions, and to prepare for calculating 2024 GHI premiums for the December payroll.

The installation of PCGenesis *Release 23.03.01* allows the user to import the SHBP option and premium updates into PCGenesis. PCGenesis identifies the “old” premium rates with an ending date of *12/31/2023*, while the new premium rates, imported with this release’s installation, display a beginning date of *01/01/2024*. *Section B3.1. Benefit Deduction Option and Tier Report – Example* provides sample results of the GHI premiums import.

The Georgia Department of Education (GaDOE) strongly urges PCGenesis users to follow the instructions for printing the results of the *Benefit Plan/Option/Tier File* update for review after the release’s installation. *Section B3: Print and Verify the Results of the Benefit Plan/Option/Tier File Report* provides the instructions to complete this procedure. After printing the report, PCGenesis users should verify ‘01/01/2024’ and ‘12/31/9999’ display as the *From Date* and *To Date* field entries for SHBP options and tiers.

Effective January 1, 2024, there are a number of changes to SHBP options:

- All GHI options remain the same. GHI options 88, B1, B2, B3, B6, H1, H2, and K1 are still available. Anthem, United Healthcare, Kaiser, and TriCare Supplement make up the available options for employees.
- All GHI tiers remain the same. Valid tiers include ‘10’ (single employee), ‘40’ (single employee/tobacco surcharge), and tiers ‘90’, ‘91’, and ‘94’ – ‘97’. Tricare Supplement, however, only offers tiers ‘10’, ‘90’, ‘94’, and ‘96’.

These instructions also contain all of the information necessary to import the Department of Community Health (DCH) employee open enrollments, to set the employee deductions, and to prepare for calculating 2024 GHI premiums for the December payroll. Review the checklist in *Section C: After PCGenesis Release 23.03.01 Has Been Installed* in this document for step-by-step instructions.

**IMPORTANT NOTE**

For the month of **December 2023**, the non-certified employer rate stays at **\$945.00**. The non-certified employer rate does not change until the January 2024 payroll.

## Section B: Installation Instructions for Release 23.03.01 Software

### B1. Perform a PCGenesis Full Backup

Proceed to section B2. *Verify Windows Security Group GENUSERS* in this document if these two conditions are met:

1. The prior evening’s full system backup was successful.
  - In addition to its current labeling, also label the prior evening’s backup media as “**Data Backup Prior to Release 23.03.01**”.
  - Continue to use the backup in the normal backup rotation.
2. No work has been done in PCGenesis since the prior backup.

Otherwise, continue with the instructions in section B1. *Perform a PCGenesis Full Backup* if these two conditions are not met.

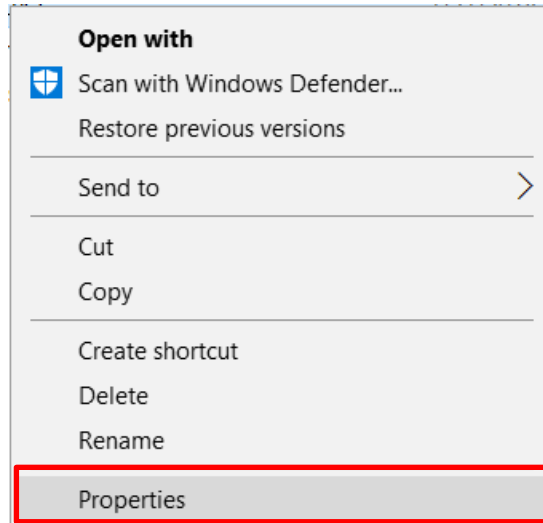
Step	Action
1	<b>Verify all users are logged out of PCGenesis.</b>
2	Stop the VerraDyne Queue Service ( <b>VQueueService</b> ) and the SQL Express Service ( <b>SQLEXPRESSPCG</b> ) prior to running a full backup of the entire <b>K:\</b> PCGenesis disk drive or else the backup will not run to completion.
3	Perform a <b>PCG Full Backup</b> to CD or DVD or USB.
4	When the PCGenesis backup completes, label the backup CD or DVD or USB “ <b>Full System Backup Prior to Release 23.03.01</b> ”.
5	<p><b>Start the SQL Express Service: <b>SQLEXPRESSPCG must be running before starting the release installation.</b></b> If <i>SQL Server</i> is not running, the <b>PCGenesisDB</b> cannot be updated during the release installation. If you run a full backup prior to installing the release and <i>SQL Server</i> has been stopped, the following commands can be executed to restart <b>SQLEXPRESSPCG</b>.</p> <ul style="list-style-type: none"> <li>• The following commands should be entered in the command prompt for <i>Windows</i> or added to the backup bat file to start the services.</li> <li>• <b>NET START MSSQL\$SQLEXPRESSPCG</b></li> </ul>
6	Proceed to B2. <i>Install PCGenesis Release 23.03.01.</i>

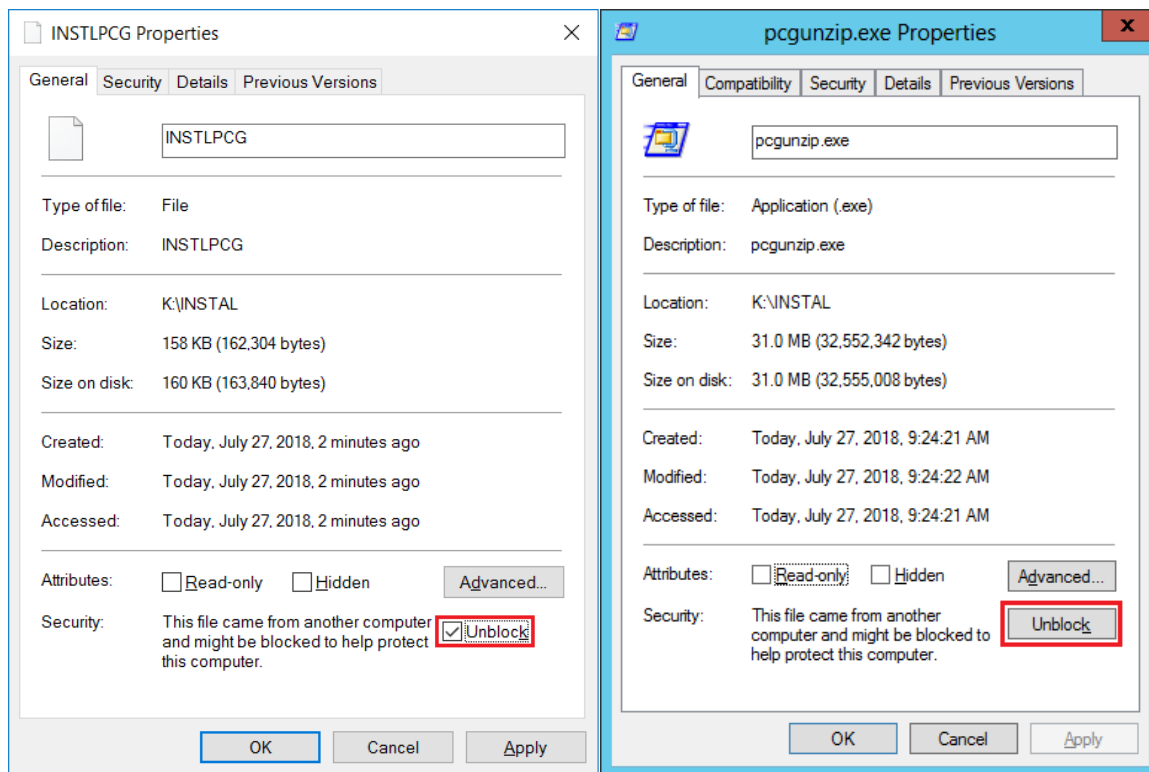

1	<b>NOTE:</b> The person installing the PCGenesis release must be the <b>Payroll Administrator</b> of the PCGenesis system.
2	<b>Start the SQL Express Service:</b> <b>SQLEXPRESSPCG must be running before starting the release installation.</b> If <i>SQL Server</i> is not running, the <b>PCGenesisDB</b> cannot be updated during the release installation.
3	<b>Verify all users are logged out of PCGenesis.</b>
4	Open <b>Windows® Explorer</b> .
5	Navigate to the <b>K:\INSTAL</b> directory.
6	Verify the single file <b>GHIRATES2024.csv</b> displays. <i>If GHIRATES2024.csv does not display, return to the MyGaDOE Web portal, and detach the file from the Web portal again.</i>
7	<p style="text-align: center;"><b>*** ALERT ***</b></p> <p>After downloading the files we need to make sure they are not blocked, otherwise when we unzip, ALL the files will all be blocked. This is a new security feature of the Windows Server 2012 / 2016 operating system.</p> <p>To check whether the files have been blocked, <b>right-click</b> on each of the downloaded files and select <b>Properties</b>. If you see a security message at the bottom, as shown below, you will need to click the '<b>Unblock</b>' button. This is a very important step!</p> <p>For each of the downloaded files in <b>K:\INSTAL</b>, right-click on the filename and select '<i>Properties</i>'.</p>

4	When the <i>Payroll System – Description/Deduction/Annuity Files Menu</i> redisplay <p><b>To print the report via the Uqueue Print Manager:</b> Select  (Uqueue).</p> <p><b>To print the report via Microsoft® Word:</b> Select  (MS WORD).</p> Follow the instructions provided in the <i>Technical System Operations Guide, User Interface Procedures, Creating the Microsoft®-PCGenesis QWORD Macro for Report Printing</i> to create the macro necessary to use the feature where appropriate.
5	Verify the <b>From Date</b> on the report reflects <b>01/01/2024</b> for all options and tiers.

<b>2</b>	<p>Stop the VerraDyne Queue Service (<b>VQueueService</b>) and the SQL Express Service (<b>SQLEXPRESSPCG</b>) prior to running a full backup of the <b>K:\</b> PCGenesis disk drive or else the backup will not run to completion.</p> <p>If the <i>Uspool</i> background task has not yet been removed from the from “<i>All Users Startup</i>”, close <i>Uspool</i> at the server. <i>Uspool</i> must be permanently removed and should no longer be running on the server.</p>
<b>3</b>	Perform a <b>PCG Full Backup</b> to CD or DVD or USB.
<b>4</b>	When the PCGenesis backup completes, label the backup CD or DVD or USB “ <b>Full System Backup After Release 23.03.01</b> ”.
<b>5</b>	Restart the SQL Express Service ( <b>SQLEXPRESSPCG</b> ). After waiting <u>at least two minutes</u> , restart the <b>VQueueService</b> in  <a href="#">View local services</a> ( <b>View local services</b> ).

## Section C: After PCGenesis Release 23.03.01 Has Been Installed

### C1. Setting up GHI Employee Rates for December 2023 Payroll

GHI employee rates effective 01/01/2024 have been loaded to the *Benefit Plan/Option/Tier rate file*. These rates are required for the **December payroll**. The following steps should be taken to load GHI 2024 enrollments and to prepare for the December 2023 payroll:

<i>Follow these steps in the order presented.</i>		
✓	Step	Action
	1	Install the PCGenesis release which updates the employee GHI premium rates for the new calendar year. This release is typically sent out at the end of November. The PCGenesis release number is typically YY.03.01, where ‘YY’ is the current calendar year.
	2	Print the <i>Benefit Plan/Option/Tier Report</i> for the <u>new</u> calendar year. Verify the correct SHBP options and tiers have been loaded into the system and verify that the employee premium amounts for each option and tier are correct. (F2, F9, F9) Refer to <i>PAYROLL: Section F: Description/Deduction/Annuity File Processing, Procedure 4A.4. Printing the Benefit Plan Record File Report.</i>
	3	Where appropriate, update the <i>Group Health Insurance (GHI) Table</i> with the correct employer contribution share. (F2, F13, F3, F7) Refer to <i>PAYROLL: Section I: Special Functions, Topic 3: Tax Tables/Withholding/Control Information Processing, Procedure A: Display/Update the Payroll Tax and Pension Tables.</i>
	4	Verify the <i>State Health Benefit Plan (SHBP)</i> system deduction setup. (F2, F9, F5) Refer to <i>PCGenesis Personnel System Operations Guide, Section D: Special Functions, Procedure 3B: Verify the State Health Benefit Plan (SHBP) Deduction Setup.</i>
	5	Download the <i>State Health Benefit Plan (SHBP) Open Enrollment File</i> from the ADP Website. Refer to <i>PCGenesis Personnel System Operations Guide, Section D: Special Functions, Topic 4: Downloading the State Health Benefit Plan (SHBP) Open Enrollment File from the ADP Website.</i>
	6	Import the <i>State Health Option and Tier</i> from the ADP File. (F3, F13, F6) Refer to <i>PCGenesis Personnel System Operations Guide, Section D: Special Functions, Topic 5: Importing the State Health Option and Tier from the DCH File.</i>

	<b>10</b>	Run the December payroll. The December payroll withholds the premiums for January SHBP coverage.

## C2. Verify Contents of the End-of-October Backup

This step is very, very important! The PCGenesis development team wants to ensure that all school districts are creating a backup of the PCGenesis data, including the contents of the **PCGSQldb** database directories as well as the **SECOND** data. Our concern is that school districts do not have a good backup of the database data, in which case you may not realize that you have an incomplete backup and *a critical problem*. School districts are under increasing pressure from hackers and malware attacks and therefore, it is nothing short of imperative that you can recover your PCGenesis data in case of an attack, or other data center catastrophe. To that end, please follow the steps below.
