



















Agriculture Teacher Program of Work (POW) Evaluations

- The 2016 POW should be available by April 1st



The classroom, FFA, and SAE combine to</u> make the complete and balanced program. Students must be trained for Career Development Events and supervised at these activities. The students must have an SAE that requires home and worksite visits by the Agriculture Teacher. These activities occur throughout the school year and during the summer. As a result the Agricultural Education Teacher should not have any after school duties and responsibilities that would conflict with the FFA and SAE activities for which they receive extended day and extended year. This would include athletic events.	No
