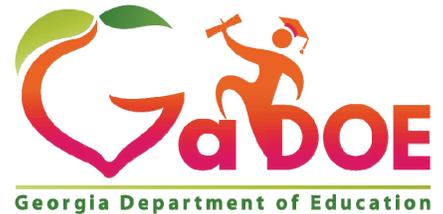

### Georgia's National Writing Project Sites: Developing Evidence-based Instruction by Teacher Leaders

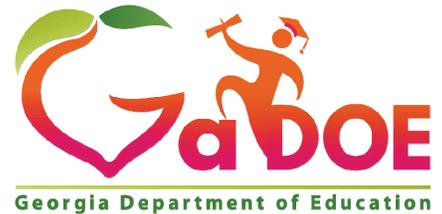

### Summer Assessment Resources

Assessment news focuses on several resources for 2017-2018 district and school planning.

First, within the next couple of weeks a revised copy of the 2017-2018 State Assessment Calendar will be posted on the Testing/Assessment Webpage under "[For Educators](#)" on GaDOE.org.

A PDF version and an Excel version will be posted to support system and school test coordinators, technology directors, educators, and other stakeholders in finding specific state testing windows, technology-specific dates, and training opportunities based on a particular assessment. For example, those EL educators requiring information regarding training dates for the ACCESS 2.0 may be able to sort the Excel version to show only the training dates and test dates needed for ACCESS 2.0.

Of note, the actual testing window dates have not changed from the 2/17/17 updated calendar. Only the formatting and training sessions have changed. This information should help district and school leadership to build local assessment plans and calendars. As noted above, the new State Assessment Calendar will be posted in the next two weeks.

Second, the "[For Educators](#)" page also shows a link to the guidance document for the "Superintendent's Test Certification Form."

The purpose of the "Superintendent's Test Certification Form" is to certify that the system adhered to all written regulations and procedures relating to testing and test administration as well as verification that any and all

irregularity documentation was sent to the appropriate program manager at the Georgia Department of Education.

System test coordinators may begin this process now; however, an email with further information will be sent in the next week.

Third, the Student Assessment Handbook is also posted on the "For Educators" webpage. This is a great resource for system and school test coordinators. This resource provides specific information on State Board policy; current state assessments; test security requirements and ethics; administration roles, requirements, and guidelines; irregularities and invalidations of assessments; and accommodations for students. Each year, the handbook is reviewed and revised to clarify policies and information. We will post a revised version of the handbook in late July, in time for the Fall Conference assessment webinars. Please take time to review this material prior to the new testing cycle.

### TLSD Partners with PSC

In partnership with the Professional Standards Commission (PSC), the TLSD team has created a series of modules supporting the new recertification requirements. ### Move On When Ready Updates & Reminders

1. Local school systems are now prohibited from excluding students in dual-credit courses from Valedictorian or Salutatorian determination. Georgia Code 20-2-161.3 (f)(4) was updated as a result of Senate Bill 211 during the 2017 legislative session. SB 211 was signed into law on April 27, 2017.
2. Exception: This does not apply to a high school student who moves into the local school system after his or her sophomore year and has not taken any courses on site at the participating eligible high school.
3. Health and PE classes are no longer available for MOWR students at TCSG's colleges beginning this Summer 2017.
4. USG colleges will only allow full-time MOWR students to enroll in PE classes (began Fall 2017).
5. Currently, an extension of length of eligibility is only available for students:
  - With a documented IEP or 504 Plan that includes an extended enrollment in high school, or
  - Who begin pursuing an SB2 Alternative Graduation Option at or before the beginning of the 11th grade, and who need an extended enrollment in high school to complete under SB2. A MOWR Eligibility Extension Request form will be available prior to July 1 from GSFC

### Are You Ready for August 21?

On August 21, 2017, there will be a celestial alignment of the earth, moon, and sun, resulting in a solar eclipse. An eclipse is a wonderful educational moment no matter where we live, but it can also be dangerous if one looks directly at the sun. The moon will move between the sun and Earth and will block the light of the sun. In other words, the moon will cast a shadow on the Earth. Some lucky areas of our state will experience a total solar eclipse, while most of us will experience a partial eclipse. Most of us know we should not look directly at the sun, but during an eclipse our curiosity and wonder can overtake our common sense. We just want to look up! It is critically important that we educate our students and communities about how to safely view an eclipse. This event will be happening around school dismissal time, so we all need to have a plan.

### Community Eligibility Provision (CEP)

What is [CEP](#)? CEP is a program that provides meals at no cost to all students in a qualifying school. A school's eligibility to participate in CEP is determined by the percentage of students that are directly certified or categorically eligible for free meals without completing an application. Students that live in a household that receives Supplemental Nutrition Assistance Program (SNAP) or Temporary Assistance for Needy Families (TANF) benefits or are identified as foster, migrant, homeless or runaway are considered categorically eligible without an application.

What are the benefits of CEP?

- All students receive breakfast and lunch at no cost;
- No more free and reduced meal applications;
- Students do not have to worry about money for meals;
- Increase in student participation in breakfast programs;
- On average, students that eat school breakfast have been shown to attend 1.5 more days of school per year and students that attend class more regularly are 20% more likely to graduate from high school;
- Students that eat school breakfast have been shown to achieve 17.5% higher scores on standardized math tests;
- Food-insecure students may be at greater risk of truancy and school tardiness. CEP helps to reduce food insecurity during the school year by allowing all students access to meals at no cost.
