The role of our Division is to work alongside the leadership of schools and districts that have been identified as Focus, Priority (SIG and non-SIG), and Opportunity to support the improvement efforts outlined in the 2015 ESEA Flexibility Request. As part of that support role, we monitor the progress of identified schools and report their progress to the GA Board of Education and to the US Department of Education. We also report that schools and districts are using federal dollars (Title I, Part A, 1003-a funds) for appropriate and effective school improvement initiatives.







# 1003(a) SCHOOL IMPROVEMENT FUNDING

Allocations for Title I, Part A, 1003 (a) School Improvement funding awards to Priority, Focus, and Opportunity schools were approved at the State Board meeting on September 25, 2015.

School use of the funding must directly relate to instruction and may be used for instructional coaches, consultants, tutors, teacher stipends for intervention programs such as after-school and summer programs, professional learning opportunities such as the Instructional Leadership Academy for Priority and Focus schools, technology, and supplemental instructional materials, books, and supplies. The Priority and Focus school principals must create a budget with the input of the school leadership team and the assigned School Effectiveness Specialist (SES), create a Justification of Expenses with the assigned SES, and send both the budget and justification to the district Title I Coordinator or Title I office. The Priority and Focus school principal, with the help of the SES, also completes Indistar requirements and uploads the school improvement plan, the needs assessment, and other pertinent documents into Indistar. Opportunity schools are provided funding for professional learning participation at the Instructional Leadership Academy.

Once all the above are completed, the aggregate of all Priority, Focus, and Opportunity budgets are entered into the Consolidated Application by the district Title I office for approval and release of funding in GAORS (Grants Accounting Online Reporting System) to the system finance office. Purchase orders are completed, goods and services are processed, and drawdowns of funding commence. All FY16 1003 (a) funding must be spent by September 30, 2016, since there is no carryover of 1003 (a) funding. An awards notification email will be sent to selected superintendents, district Title I Coordinators, designated school principals, and RESA directors.

# SIG 1003(g) FUNDING

The School Improvement Grant is a multi-step process for transforming schools. It provides opportunities for schools and their stakeholders to identify a vision for success and set a course for improvement. SIG 1003(g) is a rigorous, whole-school reform process that requires planning, commitment, focus, determination, and support. In addition to district assistance offered to SIG schools, the GaDoe provides layered levels of support for each school involved in this enterprise. Regional and state professional learning opportunities for school and district leaders are also provided periodically.

The Northwest Region Team is excited about the 2015 school year! Many thanks to the superintendents and the RESA personnel in the Northwest Region for assisting with the scheduling and invitations to team members regarding the signing of the MOAs. We welcome Dr. Phillip Luck as our Program Manager. We also welcome a new member of our School Effectiveness Specialist team, Mr. Jovan Miles, who will be working with elementary schools in Bibb County.

QCIS (Indistar) training is also underway in the Northwest Region. Griffin RESA and Northwest Georgia RESA are providing training to their districts individually; whereas the GaDOE, under the leadership of Dan DeWolf and personnel at Middle Georgia, North Georgia and West Georgia RESAs are working collaboratively to provide the training to school and district personnel.

The Bibb County School System District Review process is complete. The summary report was presented to Dr. Jones and the Bibb County School Board on Thursday, September 17, 2015. Many thanks to Sam Taylor and Phillip Luck for their support and attendance at the Board meeting.

District and school self-assessments on the non-negotiables need to be completed by November 15 and uploaded in the QCIS/Indistar platform. Several districts have requested that the self-assessment process be led by a member of the GaDOE team and this assistance begins on October 2. Terri Gaspierik will contact districts in early October to follow up on the offer of assistance that was discussed at the MOA meetings.

The GaDOE and RESA teams have started to provide training in the effective ways to use QCIS (previously known as Indistar). When planning the training, RESA and GaDOE teams collaborated with each other to determine the needs of our Focus and Priority schools and districts. The hands-on sessions have gone well and have been attended by both school and district personnel. Ongoing support will be provided to individual schools and districts as needed throughout the year.



Hancock, Johnson, Baldwin and Wilkinson personnel follow steps provided by their QCIS trainers to assess themselves on the first standard. Oconee RESA offered their facilities and provided refreshments!

Our teams are also meeting with leadership to discuss the self-assessment procedure. By November 15, schools and districts should complete this task on the school/district standards. Using an analysis of this assessment, they will prioritize their areas of need and develop one or two tasks to address them. These tasks should be entered on the QCIS/Indistar platform and will be monitored during team or leadership meetings. GaDOE and RESA members are always available for support. The MOA meetings are almost completed; it's been a pleasure to meet the district and school leaders in our region!

The QCIS/Indistar training led by Metro RESA Specialists has taken place or is scheduled in each of our districts for all Priority and Focus



school principals and appropriate district level staff. CCRPI Data Digs and Goal Setting for several of the West Metro Region schools is occurring for administrators, teachers, and Leadership Teams depending on the need. All School Improvement Specialists (Metro RESA) and School Effectiveness Specialists (GaDOE) are active in supporting the Priority and Focus schools. Turnaround leadership and district support continue to be focuses for our two SIG schools (McClarin Alternative School in Fulton and Frederick Douglass High School in Atlanta). Dr. Mike O'Neal and a team from the GaDOE successfully completed the first GSAPS review at Dunbar Elementary School (APS) on September 23rd and 24th.

West Metro would like to congratulate McClarin Success Academy, a Cohort 3 SIG School in the Fulton County School District, for surpassing their SIP goal of achieving a 20 percentage point gain in their 4-year cohort graduation rate! Notably, this has been achieved in one year. Dr. Lateshia Woodley, McClarin's Principal, attributes this success to the introduction of a personalized Student Support Team model, the redesign of the master schedule to allow for flexible learning plans, and the implementation of the Increased Learning Time (ILT) program. The Metro RESA staff has done a PHENOMENAL job training the Metro East Region Districts, Clayton and DeKalb County School Districts, administrators and GaDOE personnel on QCIS/Indistar. The delivery model utilized by facilitator Tara Ross, and assisted by Robert (Bob) Moseley, Cheryl Johnson, and Ateshia Lester was of extreme value to all the administrators!

The focus was on "the work." Ms. Ross was able to walk the participants through the unpacking process for the key standards, determining their "current reality" and task creation. Focusing on the work before ever going into QCIS/Indistar enabled the participants to see the platform as what it really is: a tool to document "the work." When she did guide participants into the platform it was an easy process for them as they already had an understanding of what they would see and how their work is to be documented/entered. The experiences she provided, her handouts, and the livebinder will equip the participants to go back to their leadership teams and replicate the process effectively with confidence!

Where do we go? How do we get there? What do we do? Why are we starting here? These are questions that the Southeast Region Team (GaDOE and



RESA) members are answering as they conduct needs assessments and diagnostic visits throughout the region. Observations in classrooms, Leadership Team meetings, collaborative planning, QCIS/Indistar, and professional learning sessions help the Southeast Region Team create a plan of priorities and services to schools. Specialists have been modeling the collaborative planning process, guiding the Leadership Team to examine the data, prompting teams to develop actions and next steps, and brainstorming intervention strategies for struggling students.

The Southeast Region Team members are focused on increasing student performance and guiding schools to embrace the process of improving teaching and learning for all students.
