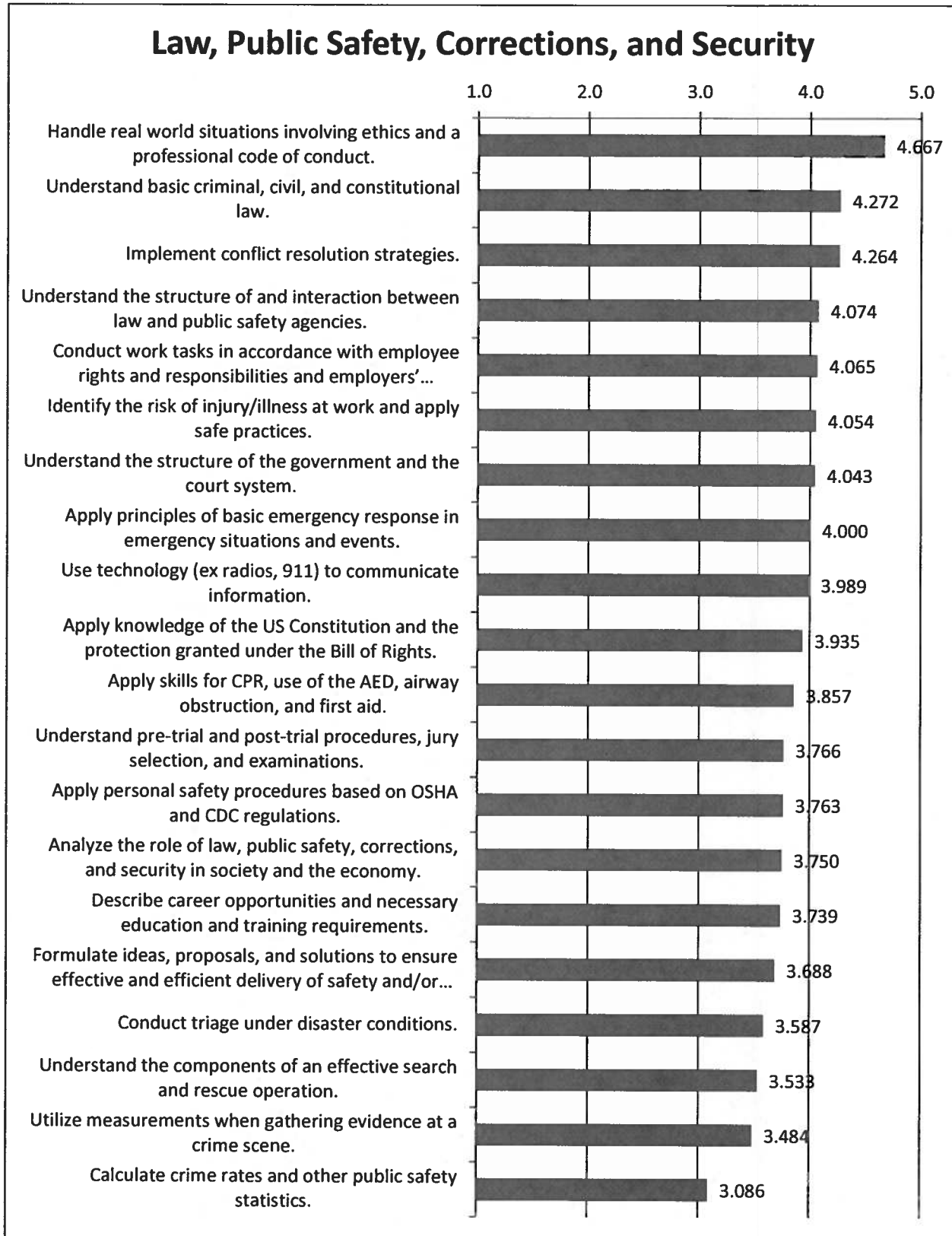

Ability to meet deadlines

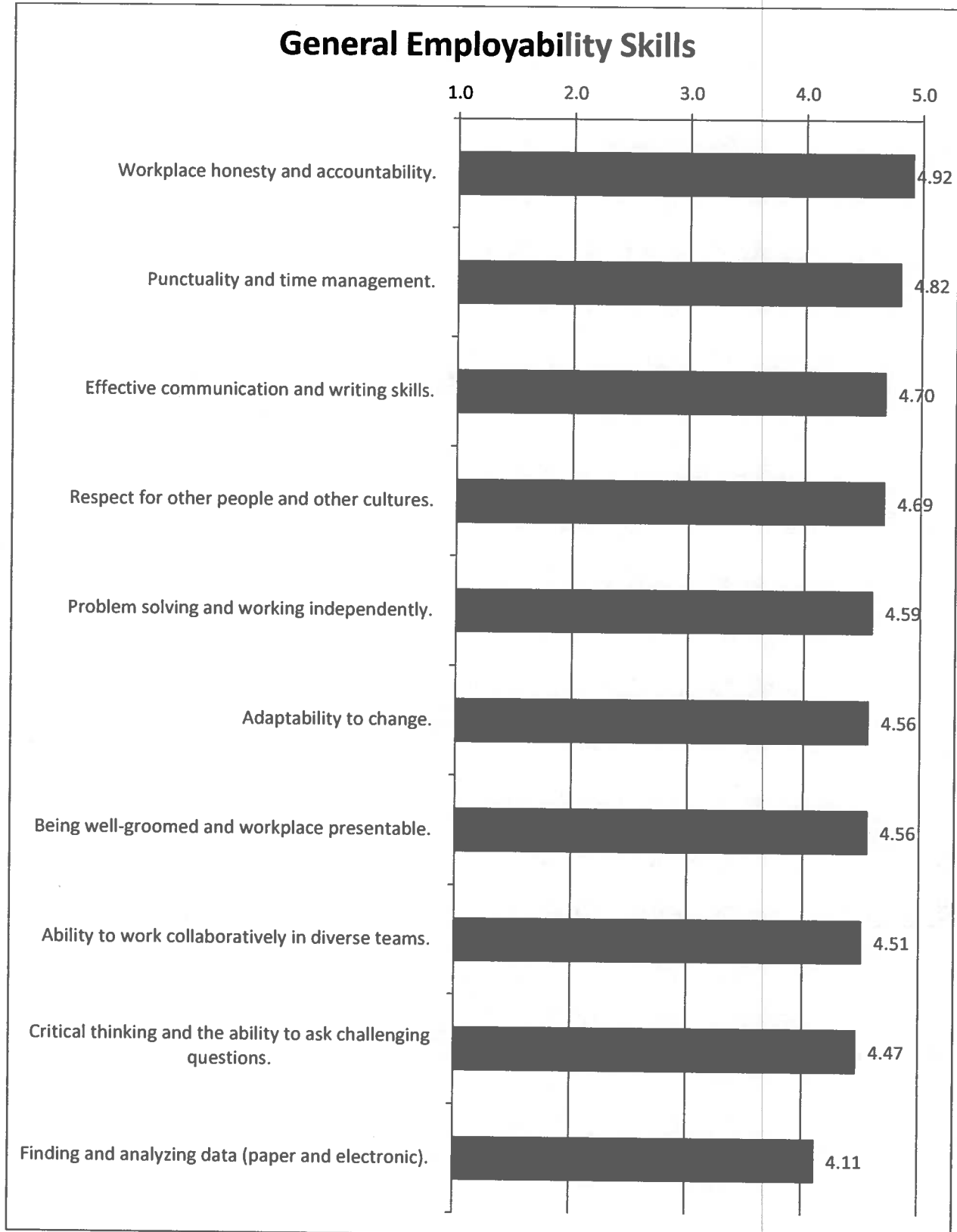
Knowledge of modern law enforcement principles, procedures, techniques, and equipment
