- 1. <u>Grant Title III, Part A Immigrant Grant to LEAs.</u> Authorized the State School Superintendent to award a grant to local school districts at a cost not to exceed \$1,514,431 in Federal Funds for the provision of supplemental services to immigrant children and youth.
- 2. Grant FY12 21st Century Community Learning Centers New Sub-Grantees

 Amendment. Authorized the State School Superintendent to award two grants to
 Candler County Schools in the amount of \$684,797, increasing the number of new 21st
 Century Community Learning Center grants from 81 to 83, for a new total cost not to
 exceed \$25,437,462 in Federal funds for non-school hour programs.
- 3. Grant FY 21st Century Community learning Center Grants Change of Fiscal Agent. Authorized the State School Superintendent to reallocate \$700,000 in Federal funds from the City of Harlem 21st Century Community Learning Center and the City of Grovetown 21st Century Community Learning Center to the Columbia County Community Connections due to a change in fiscal agent.

Authorized the State School Superintendent to award a grant to Warren County Schools in the amount of \$350,000, increasing the number of 21st Century Community Learning Centers continuation grants from 76 to 77 for a new total cost not to exceed \$24,409,795 in Federal funds for non-school hour programs.
- 6. <u>Contract FY12 Contract Covendis Technologies.</u> Authorized the State School Superintendent to enter into a contract with Covendis Technologies at a cost not to exceed \$6,000,000 in State/Federal Funds for Temporary IT Staffing.

- 8. <u>RT3 Grant Amendment Stipends for Georgia Fellows (The New Teacher Project).</u> Authorized the State School Superintendent to amend the grant with the 6 local educational agencies by the amount of \$4,000 for a cost not to exceed \$214,000 in Federal Funds for the purpose of participation in the Georgia Teaching Fellows program.

Mr. Rice seconded the motion which passed with 9 voting yes and 3 voting no.

Mr. Rice seconded the motion which passed with 7 voting yes and 5 voting no.
- **103.** Waiver Request Case 11-1214. Mr. Winter moved to approve the request for a waiver of the Georgia High School Graduation Test (GHSGT) or the Georgia High School Writing Test (GHSWT) for the student identified in case 11-1214. Mr. Rice seconded the motion which passed with 10 voting yes and 2 voting no.

Mr. Willard of the Attorney General's Office asked the members of the State Board to give the Attorney General's Office direction on what steps the Board would like to take regarding the Public Hearing for Montgomery County School Board.

After discussion a motion was made by Ms. Zechmann and seconded by Mr. Winter to approve the following motion. A unanimous affirmative vote was give by the State Board members to approve the motion. Based on refinement of the language of the motion the Board members approved the motion as follows:

The motion was "To advise Mr. Willard of the Attorney General's Office that it is the pleasure of the State Board of Education to have a full hearing of the Montgomery County School Board as it relates to Senate Bill 79. This hearing shall include the presence of and testimony from the Montgomery County Board Members. At the time of the hearing and at it s discretion, the State Board of Education may consider a consent order such as one that has been reached in previous hearings."
