#### **Resources for Leaders and Teachers**

The Progress Center led by Dr. Tessie Baily has numerous resources to support special education teachers. You will also enjoy visiting the website for High Leverage Practices in Special Education. The National Center on Intensive Intervention is another excellent source of the latest information on interventions.



Teacher resources with the most usage across the state are listed below. Hope you find some of these options helpful for your students.

- 1. Game-Based Learning Collection 3.1 million views
- -Lights, Camera, Budget! An online game designed to help secondary students learn, study, and review financial literacy topics while also practicing their budgeting skills. A collaboration with the Georgia Council for Economic Education.
- -GASHA Go! World A suite of 13 games, 7 animated videos, and support materials that teach kids ages 4-8 foundational computer science and problem-solving skills. Aligned to Georgia's computer science framework for K-2.
- -Start It Up An entrepreneurship simulator game designed to provide high school students and young adults an opportunity to experience challenges and rewards associated with starting a new business. A collaboration with the Georgia Council for Economic Education.
- -Georgia Race Through Time In this history adventure game aligned to Georgia standards for 8th grade social studies, students get to show off their knowledge of Georgia history by helping Savannah and Peaches find artifacts and beat the clock.
- -Make That Paper An online game designed to help high school students learn about the forestry industry and career employability skills. A collaboration with Georgia Forestry Foundation and aligned to CTAE standards.
- 2. Georgia Studies Collection 2.5 million views
- -Georgia Studies online course A course that teaches the Georgia standards

for 8th grade Georgia history in an interactive and engaging format.

- -Virtual Field Trips Over 40 interactive virtual field trips that allow students to explore and learn about Georgia without leaving the classroom.
- -Georgia Stories A video series consisting of 100+ streaming video segments, educator resources, and primary source materials that support the teaching of Georgia Studies.
- 3. Science Collection 976K views
- -Physics in Motion A digital series for high school physics comprised of seven units of study and 59 video segments with support materials.
- -Chemistry Matters A digital series for high school chemistry comprised of 12 units of study and 88 video segments with support materials.
- -Let's Go Enviro A digital series for high school environmental science comprised of six units of study and 26 video segments with support materials.
- 4. Economics Collection 455K views
- -Econ Express A unique online resource that helps teachers and students learn, practice, and assess basic economic concepts in a creative and engaging way. Covering 51 concepts, Econ Express serves as a general overview of the content typically taught in a high school Intro to Economics course.
- 5. Georgia Home Classroom Collection 166K views
- -Let's Learn GA! Teachers from across the state of Georgia recorded lessons and instructional support for students, teachers, and parents. Videos in all content areas can be used for student instruction and educator professional development.
- -K-12 Learning Plans Georgia Standards-based lesson plans that were specifically designed as support for school districts, administrators, teachers, and parents. The plans, designed by content specialists at GaDOE, are easy-to-use and include both "plugged and unplugged" activities.
- -School Stories School Stories is a collection of videos that highlights innovation in teaching and learning in classrooms across Georgia.
- -Georgia Home Classroom A collaboration between GPB Education and GaDOE that began as a response to the pandemic but has since evolved to provide support for educators and families for both in-person and remote learning. All GPB resources mentioned above are linked on the Georgia Home Classroom landing page, and GPB is working with GaDOE to produce more content and enhance the experience for users.

### **New Director Spotlight: Lisa Futch, Long County School District**

GaDOE is excited to feature Lisa Futch for our New Director Spotlight this week.

Lisa Futch is the Special Education Director for Long County and has been in the field of education for 25 years. Within Ms. Futch's career, she has been a middle school Special Education Teacher at the Georgia Network of Educational and Therapeutic Supports (GNETS), a GNETS Program Coordinator in the areas of counseling and school psychology, a GNETS Program Coordinator in the area of educational leadership and administration, a Special Education Director for Jeff Davis County Schools for one year, a Director of Coastal Academy GNETS Program, a part-time Site Director at Coastal Plains Charter School, a private practice licensed Professional Counselor, a certified School Psychologist, a certified School Counselor, certification in Educational Leadership, and is currently the Director of Exceptional Learning for the Long County School District.

The diversity of the student population served while working with GNETS had the most impact on Ms. Futch's educational career. The intrinsic reward that she obtained from assisting students to regulate challenging behaviors and / or mental issues both in and out of the classroom setting allowed her to recognize that working with students with disabilities was a calling rather than simply a career.

Married to John Futch for 13 years, Ms. Futch is the mother of three children: 9-year-old Ava, 25-year-old Jackson, 29-year-old Britany and son-in-law, Nathan. Ms. Futch is also Mimi to her four grandchildren: Greyson, 10 years old; Charlie, 5 years old; Connor, 4 years old, Lincoln, 2 years old, and dog mom to Murphy, a German Shepherd; Moon, a miniature Dachshund; Dixie, a Brittany Spaniel; and Log, a miniature Dachshund.

In her free time, Ms. Futch's hobbies include camping, cycling, watching Ava in dance and gymnastics, and binge-watching Netflix.

### Practice Pointers – Individualized Education Program (IEP) Team: Amendment Meeting

# QUESTION C-9: WHO MUST PARTICIPATE IN MAKING CHANGES TO THE IEP WHEN AN IEP IS AMENDED WITHOUT CONVENING AN IEP TEAM MEETING?

The Office of Special Education and Rehabilitative Services (OSERS) has emphasized in a Questions and Answers Document that under the Individuals with Disabilities Education Act (IDEA), the regulations in 34 C.F.R. § 300.324(a) (4)(i) provide that, in making changes to a child's IEP after the annual IEP Team meeting for a school year, the parent of a child with a disability and the public agency may agree not to convene an IEP Team meeting for the purposes of making those changes, and instead may develop a written document to amend or modify the child's current IEP. The IDEA and its regulations are silent as to which individuals must participate in making changes to the IEP where there is agreement between the parent and the public agency not to convene an IEP Team meeting for the purpose of making the changes.

# QUESTION C-10: MUST A PUBLIC AGENCY PROVIDE A PARENT WITH PRIOR WRITTEN NOTICE (PWN) IF AN IEP IS AMENDED WITHOUT CONVENING A MEETING OF THE IEP TEAM?

The regulations in 34 C.F.R. § 300.503(a) require that written notice consistent with the requirements of 34 C.F.R. § 300.503(b) must be given to the parents of a child with a disability a reasonable time before the public agency (1) proposes to initiate or change the identification, evaluation, or educational placement of the child or the provision of a free appropriate public education (FAPE) to the child; or (2) refuses to initiate or change the identification, evaluation, or educational placement of the child or the provision of a FAPE to the child. This provision applies, even if the IEP is revised without convening an IEP Team meeting.

# Important Budget Announcement: FY23 Maintenance of Effort Compliance Results Now Updated in the GaDOE Portal

The FY23 Maintenance of Effort (MOE) Compliance results are now updated. The MOE results can be viewed in the GaDOE Portal by going to Special Education Programs > Special Education MOE. LEAs that do not meet compliance may take allowable exceptions, if applicable, to reduce effort. Please see the Exceptions to MOE Requirement document. If your LEA determines there are applicable exceptions, please complete and return the form to your Budget Specialist with supporting documentation by March 14, 2024. **This is the final deadline**. Reconciliations must take place before this deadline. Please begin the reconciliation process as soon as possible. This process can be time-consuming and may require the support of your Finance Office. If eligible exceptions are not determined, repayment may be required. Please note, that budget amendments will be delayed until MOE Compliance is met.


