



Understanding the Overview

The Overview page provides general information about the school or district including school/district information and school/district demographics. The 'All' Overview page displays summary boxes for School Climate and Financial Efficiency. (Financial Efficiency is added to the reports in January.) Clicking on the grade cluster (Elementary, Middle, or High) next to the word ALL allows the user to view the Overview page with summary boxes for each CCRPI component. This at-a-glance page introduces the user to a school or district.

Key Terms for Overview

ESSA –The Every Student Succeeds Act, commonly referred to as ESSA, earned bi-partisan approval in 2015. States were freed from their No Child Left Behind (NCLB) waiver agreements and given the responsibility to develop state plans to support education. ESSA significantly scaled back the authority of the Secretary of Education and U.S. Department of Education. Though ESSA gave states additional authority and flexibility over their education system, wholesale flexibility was not granted, and statutory requirements vary in specificity from issue-to-issue.

Georgia has sought maximum flexibility while creating a cohesive and aligned plan that is responsive to stakeholder feedback and supports our vision of offering a holistic education to each and every child in the state.

Grade Cluster – the type of school group (elementary, middle, or high) based on grade levels.

High School – grades 9 through 12.

Middle School – grades 6 through 8.

Elementary School – grades K through 5.

Number of students enrolled - number of students with an enrollment record at any time during the school year at that school, district, or the state.

Overall CCRPI Score - consistent with state law (O.C.G.A. § 20-14-33), the overall CCRPI score is reported on a 0-100 scale. Each CCRPI indicator and component is also reported on a 0-100 scale. The maximum score for an indicator or component is 100. Components will be weighted and combined according to the weights defined in the table to determine the overall CCRPI score.

FAQs about Overview

How is the 'All' score calculated for a district?

The 'All' score is the single score for a district. The district's student enrollment count at each grade band is calculated (K-5 for ES, 6-8 for MS, 9-12 for HS), and the district's total student enrollment count is calculated. The percent of enrollment by grade band is calculated by dividing the district's enrollment count at each grade band by the district's total enrollment count. The percent of enrollment for each grade band is multiplied by the CCRPI score for each grade band. The resulting values are the proportional points by grade band. The sum is the single score for the district.

How does the *All Schools in the District* table at the bottom of the page work?

Clicking on the green *Filters* box allows the user to view available filters. The *All Schools* box allows the user to filter on a grade cluster. The *CCRPI Overall Score* bar allows the user to choose a score range. Once filters are chosen, click *Apply*. There is also an option to display 10, 25, 50, or 100 schools in the district. The arrows in the table itself allow scoring from highest to lowest, or lowest to highest for the overall score, each component, or star ratings.
