Superintendent's Test Certification

The Superintendent's Test Certification completion for all Fall and Winter Georgia Milestones assessments (July 1 – December 31) is due by **Tuesday**, **January 31**.

System Test Coordinators (STCs) must complete the Superintendent's Test Certification form in the MyGaDOE Portal.

- 1. Open the Superintendent's Test Certification Form.
- 2. Click **Add New Record**, choose "Session ending January 31," and set "Year" to "2023".
- 3. Complete the form. You are required to respond to all questions.
- Click Submit. A notice will automatically be sent to the district superintendent in the MyGaDOE Portal to Approve or Reject the submission.
- 5. Once the superintendent has approved the form, the process is complete and requires no further action by the STC.

The Superintendent's Test Certification User Guide is available in the top right-hand corner of the application in the MyGaDOE Portal.

Test Development

Nomination of Educators for Test Development Activities

The nomination window for Georgia Milestones and GAA 2.0 test development activities has closed. All nominees will receive an email request to apply for participation. In this application, nominees will provide information regarding teaching experience and availability to participate in the upcoming meetings. These emails will be sent from the CVENT meeting planning platform. Nominees may need to check their Clutter, Junk, and Spam folders, as these emails will occasionally be received in those folders.

GaDOE will select participant panels for each meeting to ensure a representative sample from across the state based on grade level and content area. Meeting invitations will be sent by the end of March, including specific meeting details. Invited educators must confirm acceptance of the invitation. If





an educator declines an invitation, does not respond, or cancels before the meeting, an alternate will be selected from the nominee pool.

DRC BEACON

How has DRC BEACON helped you improve instruction in the classroom?



After two years of administering the full battery of DRC BEACON assessments twice a year, Forsyth County decided to do something different for the 22-23 school year. Each elementary and middle school was challenged to write a ReThink BEACON Plan. Schools were given full autonomy to decide how they would use BEACON to drive classroom instruction. The plan involved answering **who** was going to test, **wha**t tests/testlets would be given, **where** testing would happen **when** testing would occur, **why** they were testing, and **how** the data would be used.

So far, the results have been excellent. Schools have taken ownership of BEACON! Data are being used to differentiate instruction in the classroom, group students based on the need for remediation and enrichment during MTSS support time, and so many more creative ways to meet students' needs. For districts thinking of using BEACON, I highly recommend involving schools in decision-making.

Mid-Year Guidance and Reports Webinar

Attendees at the Thursday, February 9 DRC BEACON webinar, *Mid-Year Guidance, and Reports,* will learn how BEACON enables students, teachers, and school/district leaders to use data to inform instructional practices. In addition, this webinar will include comments from Brantley County's STC, Angela Haney, detailing how BEACON is used in her district to support teaching and learning and providing her local handouts on how to use BEACON in the most meaningful ways.

Formative Instructional Practices (FIP)

GKIDS 2.0 and GKIDS Readiness Check

Mid-Year Checkpoint – Early to Mid-February

Teachers should prepare to have student data entered in the platform by the suggested mid-February checkpoint. This checkpoint is a reminder for districts to ensure that teachers stay updated with instructing, assessing, and recording student performance on the kindergarten academic standards. STCs and School Administrators can generate reports in the platform to check school

progress. State reports are not created for this checkpoint.

The recent training on Thursday, January 26, reviewed suggestions for reviewing and monitoring data during the mid-year checkpoint. This training guided educators working with students who are deaf or hard of hearing (DDH) and the administration of GKIDS 2.0. In addition, examples were given regarding suggested changes to GKIDS ELA Learning Targets for these students due to their specific learning needs. For English language arts, the Keens recommend:

- Hometown Heroes and Classroom Detective are fun, interactive reading-literary games with a combined focus on Key Ideas and Details, Craft and Structure, and Integration of Knowledge and Ideas. Both engage students in a literary text in a unique, interactive design and encourage students to read and compare texts using the RL9 standard.
- Museum of Mysteries, Harbor Phonics, and Peachling Playground formatively assess your student's reading readiness. These games have proven to be highly popular and help to promote student self-efficacy in literacy.

For mathematics, the Keens recommend:

- For Grade 1, Unit 4: Sorting, Comparing, and Ordering: Maintain current Peachling Gym and Treat Factory assignments and add *Bargain Hunters* and *Carnival Time*.
- For Grade 2, Unit 4: Applying Base Ten
 Understanding: Maintain current assignments of
 Cloud Hopper and Treat Factory and add Farmers
 Market, Captain Peachbeard, and High-Rise
 Builders.

ACCESS for ELLs

ACCESS for ELLs Administration Window and Materials Return

The ACCESS window closes Friday, March 3. All English Learners must participate in ACCESS testing, including those students whose parents have refused ESOL services.

Once your students in grades 1-3 have completed the ACCESS for ELLs Writing test, please return your test materials to DRC. The timely return of these materials ensures that DRC can distribute score reports as scheduled. In addition, be prepared to send the remaining testing materials to DRC immediately following testing. Again, returning secure material early or on time supports the quality of ACCESS for ELLs scoring and ensures that score reports are not delayed.

Data Validation Process

STCs and their ESOL colleagues should collaborate to ensure student demographics, accommodations, test results, and records are accurate during the data validation process. This process is accomplished in two stages.

- Stage I: Pre-reporting data validation (Thursday, March 30 to Wednesday, April 12) occurs before initial reporting and impacts reports (printed and posted in WIDA AMS) and data files.
- Stage II: Post-reporting data validation (Monday, May 8 to Friday, May 19) occurs after reports and data files have been posted to WIDA AMS. Any changes made during post-reporting data validation result in the delivery of new data files, and new electronic (PDF) reports.

Move On Criteria

Follow up with teachers administering Alternate ACCESS and Kindergarten ACCESS to ensure they understand how the "moving on" boxes in the test administrator script work in conjunction with the Student Response Booklets. The "moving on" boxes let the examiner know whether they should move on to the next test level or stop and go to another part. Irregularities occur when Test Examiners misunderstand these test administration procedures.

Alternate ACCESS Field Test

The Alternate ACCESS field test window opens Tuesday, February 14, and closes Monday, April 17. The field test is <u>required</u> and occurs at every school with students eligible to take Alternate ACCESS. Field test materials will arrive at sites as early as Tuesday, February 7. STCs do not need to place an order for this initial field test shipment. All sites with students who took Alternate ACCESS during the 2021-22 school year will automatically receive materials.

Remember!

- Kindergarten English learners with significant cognitive disabilities will take Kindergarten ACCESS and the Alternate ACCESS Field test.
- English learners with significant cognitive disabilities enrolled in grades 1-12 will take Alternate ACCESS and the Alternate ACCESS field test.

Georgia Alternate Assessment 2.0 (GAA 2.0)

Last month during the Test Setup and Pre-Administration webinar, STCs had the opportunity to ask questions about GAA 2.0. You may find the responses to some of these questions informative.

When do GAA 2.0 test materials arrive in school districts?

GAA 2.0 test materials will be delivered to districts on Monday, March 13. Once STCs inventory these materials, they can place an additional order in INSIGHT if needed.

When will STCs and School Test Coordinators (SchTCs) be able to set up registrations?

STCs and SchTCs can set up registrations in the DRC INSIGHT Portal on Monday, February 27.

Where can the Test Examiners go to practice using the Online Response Entry Application?

Once STCs create user accounts and assign the Online Scoring Teacher Permission to Test Examiners, they can access the Test Administration Practice Site. Users can interact with five practice forms per content area (ELA and Math) in the Online Response Entry application to become familiar with navigation before the assessment window. To access the site:

- Login to the DRC INSIGHT Portal.
- Navigate to Online Response Entry from the My Applications menu.
- Select 'Test Administration Practice' from the Registration Window dropdown.

When can the Test Examiner preview test material to prepare for test administration sessions?

The Secure Preview Window opens Monday, March 13. STCs will create user accounts and assign the Online Scoring Teacher Permission to Test Examiners in User Management. Test Examiners can access the Secure Online Script to prepare for administration. To access the Secure Online Script:

- · Login to the DRC INSIGHT Portal.
- Navigate to Online Response Entry from the My Applications menu.
- Select 'GAA 2.0 Spring 2023' from the Registration Window dropdown.

Spring/Summer 2023 EOG and EOC Pre-Administration and Test Set-up Training

The Spring/Summer 2023 EOG & EOC Test-Setup and Pre-Administration Webinar for Georgia Milestones is Tuesday, February 21, from 10 a.m. – 12 p.m. Discussion points include test security, administration scheduling guidance and protocols, test set-up and accommodations, and reporting. In addition, this session provides STCs details for scheduling, managing, and monitoring testing and includes information that can be used to support local training. Test Administration Manuals

Test Administration Manuals for the Spring 2023 Georgia Milestones EOG and EOC administration have been posted and can be found on the <u>DRC INSIGHT Portal</u> and the <u>Georgia Milestones Resources</u> page.

DRC INSIGHT Participants and Registrations

New functionality has been enabled in DRC INSIGHT to allow student demographic and accommodation data to be either manually entered or uploaded into DRC INSIGHT to carry over from one test administration to another.

Although this functionality is available, districts can still upload or manually edit students if the current information needs updating. For example, a new participant file (MSU), accommodation file, or roster file can be uploaded before the administration if student information has changed or errors have been corrected.

An STC may use this new functionality to save time registering students for smaller test administrations such as EOC Spring Mid-Month and EOG Retest. For example, students uploaded for the EOC Winter administration can be assigned an EOC Spring Mid-Month assessment without manually entering or uploading a participant file (MSU). In addition, any accommodations attached to students that were previously entered or uploaded will also carry over when student registrations are created for EOC Spring Mid-Month, as will any student roster information attached to the student (i.e., for Teacher Reporting).

It is strongly recommended that districts upload new files for the Main Spring administration of EOC and EOG to ensure that the most accurate data are available in DRC INSIGHT for these test administrations. This new functionality allows students uploaded for the Main EOG Spring administration to be automatically available for assigning an EOG Retest administration, if necessary. In addition, accommodations and roster information for students that have been previously entered or uploaded will carry over with them.

Assessment Data Validation

Accurate student demographic information must be loaded into DRC INSIGHT so that assessment data can be matched to the data found in Student Record and

Student Class. Therefore, districts are encouraged to verify that data in their Student Information System (SIS) are accurate, and that any data uploaded to DRC INSIGHT via the upload files for ACCESS and Georgia Milestones match the SIS data.

School leaders and teachers can help check data by reviewing local attendance rosters for accuracy. Any errors found should be corrected in the SIS first before creating upload files and transmitting them into DRC INSIGHT. If data errors are found after the upload to INSIGHT, these should still be fixed in the SIS first. Then, new data files can be created and re-uploaded to INSIGHT.

Some common data errors to look for include the following:

- Missing or incorrect GTIDs
- Duplicate student names
- Incorrect spelling or hyphenation of student names
- · Reversals of student's first name and last name
- Missing or incorrect birthdates
- Students incorrectly associated with "service" School instead of their "home" (FTE) school

Reporting Updates

Final reports and data files for Fall Mid-Month and Winter 2022 will be available in DRC INSIGHT and the MyGaDOE Portal according to the schedule shown below. It takes approximately three weeks for the ISRs to be processed and posted to the SLDS; the tentative availability date is Wednesday, March 1.
