## Policy Update

### **U.S. Department of Education Denies Georgia's 1% Alternate Assessment Waiver Request and Appeal**

Federal law requires that states assess no more than 1% of students on the alternate assessment aligned with alternate academic achievement standards. Georgia has historically exceeded 1% and received a federal waiver from this requirement in 2017-2018, which has been extended each year since. However, the U.S. Department of Education (USED) has denied Georgia's request to extend our 1% waiver to the 2022-2023 school year. In their denial letter, USED cited Georgia's increase in the percentage of students participating in the GAA 2.0 in 2022 (approximately 1.4%) compared with 2019 (approximately 1.3%). We appealed USED's denial of our request to extend our waiver to 2022-2023, which USED denied. With the loss of a federal waiver to exceed 1% of students participating in the alternate assessment, we will need to take additional actions as a state to ensure we start reducing the percentage of students participating in the GAA 2.0. We will provide additional information when available.

### **Assessments Aligned to New Mathematics** Standards for 2023-2024

Georgia Milestones, GAA 2.0, and GKIDS mathematics assessments have been revised to align to the new Georgia K-12 Mathematics Standards and will be administered beginning in the 2023-2024 school year (beginning with the Winter 2023 EOC administration for Georgia Milestones). Given the implementation of these new mathematics assessments, standard setting meetings will occur in Summer 2024 to set achievement expectations (cut scores) for each achievement level for Georgia Milestones and GAA 2.0.

Therefore, the reporting of results for the mathematics assessments in 2023-2024 will be delayed until late summer 2024. Given this delay in reporting, we will recommend to the State Board of Education (SBOE) at their June 14-15 meeting that the state promotion law for grades 5 and 8 and the EOC final grade requirement (20% of students' course grades) be waived for mathematics for the 2023-2024 school year. An update on the SBOE meeting will be provided in July.

### **ELA Standards Update**

Georgia's new K-12 English Language Arts (ELA) Standards were adopted at the May 2023 SBOE meeting and will be implemented beginning in the 2025-





2026 school year. All state assessments will be revised to align with the new standards.

We do not anticipate changes to the design of the GKIDS 2.0 and GAA 2.0 ELA assessments. We do, however, anticipate more changes will occur with the Georgia Milestones test design. The timeline and process for developing new Georgia Milestones ELA assessments is below.



Some of the changes under consideration include a new design for Section 1 (the essay section); the inclusion of multi-modal texts, including listening and/or viewing audio and/or video content in Section 1; and the use of new technology-enhanced item types. The new essays and item types will be examined with students during the Fall 2023 cognitive labs to assess the feasibility and value of including them in the updated assessments. Importantly, there will be a statewide pilot in fall 2024 to field test the new essays and other item types. This pilot will enable us to complete rangefinding prior to the first operational administration so as not to significantly delay reports and to provide educators with sample essays with scored student writing at the beginning of the 2025-2026 school year. As test development meetings with Georgia educators begin this summer, we will share additional information about the design of the new ELA assessments.

# Important Technology Update

System Test Coordinators (STCs) must share the following information with Technology Directors (DRC Tech Bulletin).

Beginning **Friday**, **June 30**, DRC is implementing a security enhancement that may affect some sites and require local IT staff to change the way they update the DRC INSIGHT Secure Browser software on testing devices. Moving forward, only Admin-level users will be allowed to update the DRC INSIGHT Secure Browser on **Windows and macOS** testing devices.

### Sites that are impacted:

- Sites that manually update the secure browser on each Windows or Mac testing device.
- Sites that have enabled the auto-update feature for the secure browser. This will no longer be an option moving forward.

### Sites that are NOT impacted:

- Sites that use iPad or ChromeOS devices for testing.
- Sites that use deployment software to update multiple testing devices at once.


Impacted sites should plan to ensure the secure browser is updated as soon as possible after Friday, June 30, before student testing is scheduled to begin. Updating the secure browser is required to allow students to test after Friday, June 30.

### **Superintendent Test Certification**

The Superintendent's Test Certification is due by Monday, July 31 for all assessments including GKIDS 2.0, WIDA ACCESS, WIDA Alternate ACCESS, GAA 2.0, and Georgia Milestones. STCs must complete the Superintendent's Test Certification form in the MyGaDOE Portal.

- Open the Superintendent's Test Certification Form. If you do not see this option, your security officer must request this permission for you in the MyGaDOE Portal.
- 2. Click **Add New Record** to open and complete the form.

- Click Submit. A notice will automatically be sent to the superintendent in the MyGaDOE Portal to Approve or Reject the submission.
- 4. Once the superintendent has approved the form, the process is complete.




The <u>Superintendents Test Certification User Guide</u> is available in the top right-hand corner of the application in the MyGaDOE Portal.

### New System Test Coordinator Assignment

The Assessment Division has begun to receive notices of changes in personnel holding the role of STC/ Assessment Director for local districts. The *Student Assessment Handbook* provides the specific protocols for assigning STCs (p. 18).

Due to the confidential nature of student information, assignment of the role of STC (otherwise known as Assessment Director) must be made by the superintendent of the district or state charter school through the local security officer in the MyGaDOE Portal and in the **Primary Role Management (PRM)** application (<u>User Guide</u>) also found in the MyGaDOE Portal. The security officer must include a primary and/or secondary Assessment Director in this application identifying the full name and email address for both individuals. This assignment allows the STC to receive data files and emails from the K12 Assessment Director listsery.



Once a new STC has been identified in the Primary Role Management application, GaDOE Assessment

Specialists send a notice to vendors regarding the appointment of the STC to ensure new accounts are created in online assessment platforms for district and school management and monitoring of assessments.

A role request must be made by the security officer in the MyGaDOE Portal allowing access to the STC for the following **assessment forms**:

- Testing Irregularity Form (TIF)
- Rescore Request
- Superintendent Test Certification (Edit)
- Special Accommodations Request

# Georgia Assessment and Training Calendar

The 2023-2024 Georgia Assessment and Training calendar has been posted on the <u>For System Test Coordinators</u> site. This calendar includes all test administration windows and training sessions.

All assessment-specific training registration links are found in *GaDOE Professional Learning Events*. Sessions are listed each month in the Assessment Update. STCs must review the upcoming trainings to determine the need to forward to appropriate personnel such as Technology Coordinators, Special Education Coordinators, and ESOL Coordinators.

### **New Assessment Training Plan**

Each school year, the Office of Assessment and Accountability provides various test administration trainings to STCs for all state assessments. Notification to STCs is by memoranda found on the Georgia Student Assessment Program website, For System Test Coordinator link that is posted annually. In addition, announcement of all training sessions is found in the monthly Assessment Update newsletters posted on the same link. All STCs are required to attend the mandatory webinars noted in the calendar found in the memorandum as well as on the Georgia Assessment and Training Calendar posted on the website. Attendance will be recorded and collected for all sessions.

Asynchronous courses provided through Georgia Learns must be completed annually by STCs, SchTCs, Test Examiners, and Proctors. Staff will receive a completion badge and certificate once they have completed the course successfully. STCs and SchTCs are responsible

for collecting documentation of all Georgia Learns course completion certificates from staff and educators prior to any test administration windows and beginning any test sessions.

STCs and SchTCs are instructed to clearly document attendance at all local training sessions and include agendas and supporting presentations and/or handouts with specific guidance and policy related to test security and assessment administration protocols. Training must include a review of Examiner's Manuals and define and clarify test security breaches and potential opportunities for irregularities and invalidations. Local training must clearly articulate the process and procedure for reporting irregularities for review by the STC and subsequent reporting to the Office of Assessment and Accountability for review.

# Formative Instructional Practices (FIP)

### FIP as Independent Learning

FIP Online Professional Learning directly supports Georgia's System of Continuous Improvement. More specifically, the modules support the strands for Curriculum, Assessment, Instruction, Professional Learning, Leadership, and Planning and Organization. Family and Community Engagement can also improve because the content in FIP helps educators communicate more accurately about the interconnectedness among academic expectations, formative and summative assessment results, and student learning progress. Leaders can be assured that FIP provides Tier 1 evidence-based practices for district or school improvement.

Leaders structure and frame professional learning in various ways. Likewise, FIP can be planned in many ways depending upon the goals for improvement. Key considerations include the roles of participating educators and purpose based on student needs for greater learning and staff needs for growth. FIP as a *Knowledge-building process* is just one option that can be used as an independent learning journey for growth. In a Knowledge-building implementation, leaders, teachers or coaches independently enroll in and complete FIP modules to reflect on how the content applies for use in their setting. This model works well in schools or districts with a legacy of student learning success.

How does this work? Leaders introduce FIP to other leaders, teachers, or coaches. The school-unique and role-based access codes are provided to educators to create individual online learning accounts in the FIP platform. Provide the FIP webpage login and directions for creating an online learning account. Share the FIP <u>All Courses Flyer</u>.

Another way to implement FIP as a *Knowledge-building* process is for a learning team to make notes to self about their learning from a module. Then, each team member can share their anonymous notes on an infinity T-chart. Use the left side of the chart to list new practices learned and the right side to list when the new practice might be used. All members of the learning team can read the notes over time and gain professional insights for planning and use.

Use of either the self-selected option or the independent learning team option allows educators to determine when and how to learn and can establish independent accountability. FIP as a Knowledge-building process is just one way to move district and school improvement forward. Most importantly, it offers leaders an effective way to create choice within an accountability system. There is research to support that when educators are allowed to make choices among appropriately constrained options, they get better, and student learning improves. What is a constrained option? It is the leader's keen knowledge of and ability to create targeted choices from a menu that is only related to what students need to improve learning.



### **Georgia Milestones Lexile Scores**

Lexile scores are a valuable tool that can be used to help students improve their reading comprehension. Lexiles are a measure of a text's difficulty, and they can be used to match students with books that are at their appropriate reading level. When students read books that are at their level, they are more likely to be successful and to enjoy reading.

In Georgia, students will receive a Lexile measure when they receive a scale score on a Georgia Milestones Endof-Grade or End-of-Course ELA assessment. When parents and teachers know their students' Lexile levels, they can select books that are challenging but not too difficult. This helps students to grow as readers and to develop a love of reading.

Teachers and school leaders can view Lexile scores on Class Rosters in Interactive Reporting in DRC INSIGHT. Scores can be sorted and compared to overall scores on the ELA assessment. Teachers can create leveled reading lists for students, differentiate instruction based on Lexile levels, and help monitor student progress in reading.

The Lexile score is also found on the Individual Student Report with a link to the Find-a-Book database for summer reading.

The Lexile Framework® for Reading matches a student's reading ability with the difficulty of text material. When selecting books, it is important to consider that Lexiles do not address age-appropriateness, student interest, or text quality. Suggested titles are not necessarily endorsed by the Georgia Department of Education. The <u>Lexile Hub</u> allows students to search for books by interest, grade level and text complexity. Students can then go to their library and pick up these books for reading that they know meet their level and interests.

One school used Lexiles to create an afterschool book club for grade bands of students. Books were selected based on student interest and aligned to a specific Lexile range. Students then signed up for book club and chose a book to read within their known Lexile range and reading interest. Students then met after school to read

and discuss their books with their peers. This club proved to be very popular with students and motivated them to read independently and discuss books in a fun and friendly environment.

Note: Preliminary reporting for the 2023 EOG Retest is scheduled to begin on Tuesday, June 6. The last day for teachers to see their students' scores in DRC's Interactive Reporting system is Friday, July 14. STC and SchTCs will have no change to their access and permissions; however, STCs should review the roles of district and school personnel starting Monday, August 1 and make updates as needed.

### **MSU Layout Updates for 2023-2024**

An exciting change is coming for the Multiple Student Upload (MSU) for SY2023-24. Free/Reduced Price Lunch (FRPL) Eligibility will be added to the MSU, and the data collected on this field will be reported in the Georgia Milestones system data files for district use. In the MSU, the FRPL Eligibility field will be *required* and will take the following acceptable values:

- F = Student is eligible for free meals
- R = Student is eligible for reduced-priced meals

- N = Student is not eligible for free or reduced-priced meals
- C = Student is enrolled at a CEP school
- P = Student is enrolled at a *Provision II Both* school

*Note:* Blank is not an acceptable value for the FRPL Eligibility field.

GaDOE's Data Collections and Assessment teams will communicate the addition of the FRPL Eligibility field to the MSU to the SIS Vendors in early June and will convey the expectation that the district's SIS and MSU file extract will be ready by August 2023. STCs are encouraged to collaborate with their local SIS data specialists and Nutrition staff to ensure timely and accurate FRPL Eligibility data entry into their SIS. They may also reach out to their SIS Vendor representative if they have any questions about the timeline and availability of the updated MSU.

## Accountability Update

The Live Data Verification tool is available to district and school users with 2023 Student Record and Student Class data. Please remind principals and district staff to check the data files using the recorded webinars, user guides, and other resources available in the MyGaDOE CCRPI portal under CCRPI Resources for guidance. Information in the tool is updated nightly, based on Student Record and Student Class uploads submitted by districts. District staff and principals should check the data carefully. Any errors must be corrected in Student Record and/or Student Class before the collections are certified by your superintendent in June. It is critical that data are correct for use in the 2023 CCRPI calculations.

Remember to finalize district plans now for completing the summer CCRPI applications. The **Assessment Matching** application, currently available in the portal with national assessments, will be updated with new assessments to match as they become available. The Non-Participation application, Cohort Withdrawal Update application, and Summer Graduate collection will be available in July. The GAA 1% application will be available for a short window in August. School staff should be collecting documentation now for districts to utilize in completing the applications. All applications will close in late August. Look for emails with the exact closing dates and resources for the applications as they open. If you are not responsible for completing an application, be sure to forward the email to the appropriate staff in your district.

Please contact the GaDOE <u>accountability specialist</u> assigned to assist your district with any questions or concerns. Remember that your district accountability Point of Contact gains critical time-sensitive information at the Monthly Accountability Updates and is another good resource for you.
