Policy Update

BALANCED APPROACH TO ASSESSMENT

We are excited about our state's transition to a more balanced approach to assessment beginning with the 2020-2021 school year. This approach includes the previously announced enhancements to Georgia Milestones that reduce student time spent on statewide summative testing and the introduction of DRC BEACON as an optional through-year formative assessment resource at no cost to districts.

More information about the upcoming Georgia Milestones enhancements and DRC BEACON is available in this newsletter. We believe this more balanced approach to assessment will maintain a purposeful amount of accountability while redirecting time and resources toward improving student learning during the school year.

As you are making plans for resuming school later this summer for the 2020-2021 school year, I know many of you have questions about what statewide assessment will look like next year. While we all face uncertainty about what the coming months and the new school year will bring, the GaDOE Assessment and Accountability team is committed to supporting your focus on resuming instruction and other supports for students. We are aware of the challenges you are facing in the new school year and are open to providing as much flexibility as possible to ensure the state's assessment program supports your efforts.

GEORGIA ASSESSMENTS CANCELLED FOR SUMMER 2020

As a reminder and due to the continuing nature of the COVID-19 pandemic, the summer administration of the Georgia Milestones EOC has been cancelled. Students who completed EOC-required courses prior to July 31 (Spring/Summer 2020) are waived from the EOC requirement and are not expected to participate in the EOC in any subsequent windows.

Districts will be able to utilize the August mid-month and other future administrations for students who complete EOC-required courses after July 31. The <u>FAQ document</u> found on the Testing/Assessment Website has been updated to include more guidance regarding the cancellation of assessments through this time period.

Assessment Updates

Georgia Assessment and Training Calendar

The Georgia Assessment and Training Calendar has been posted on the Testing/Assessment webpage under the For Educators link. Currently, test administration windows, training dates, and tasks have been posted for GKIDS 2.0, Georgia Milestones, Keenville, BEACON, NAEP, TestPad and Formative Instructional Practices (FIP). Additional dates are expected to post for GAA 2.0 and ACCESS and Alternate ACCESS for ELLS later this month. In addition, trainings for System Test Coordinators (STCs) including the Fall Conferences, Technology Directors Training, and Assessment Lunch and Learns are also noted in this calendar.

As a reminder, training links will be posted to the Key Training Dates section of the Assessment Update.

Separate emails will not be sent. In addition, STCs are reminded to review any assessment administration tasks requiring attention in the Key Tasks and Reminders section.

Return of Materials

Any secure test materials delivered and received at the district may be returned to the vendor at this time following guidance found in the Test Coordinator's Manual. This includes ACCESS for ELLs, GAA 2.0, and Georgia Milestones. Georgia Milestones TAMs should not be returned. **EOC TAMs should be held for the 2020 fall mid-month administrations.** EOG TAMs should be recycled or destroyed at the district. Any secure materials must be returned to the vendors.

DRC BEACON

Beginning September 2020, DRC BEACON will be available to all Georgia districts. BEACON is a through-year, computer adaptive, formative interim assessment system administered in ELA and mathematics in grades 3-8. It measures progress throughout the school year, allowing educators to target instruction and make informed decisions. It is mapped to the Georgia Standards of Excellence (GSE), adjusts difficulty to meet students where they are, and minimizes testing time.

BEACON is aligned with Georgia Milestones in multiple ways, including the standards assessed, item types administered, delivery platform used, and tools and accommodations available. In year 2 it will also provide estimated performance on the end-of-year Georgia Milestones assessment. Ongoing field testing of newly developed BEACON items allows for future alignment to our standards when the GSE are revised.

This tool will be truly formative – it will not be used for high-stakes purposes such as student or school accountability. The shortened Georgia Milestones end of year assessment will continue to fulfill state and federal testing and accountability requirements.

BEACON will provide immediate and detailed results to inform instruction. Districts have flexibility in determining how best to utilize this formative tool. Choices may include administration as full content area assessments in ELA and/or mathematics or as "testlets" in specified domains.

BEACON is being provided free to all Georgia districts and schools as an optional formative assessment resource.

GKIDS 2.0 and GKIDS Readiness Check

END OF YEAR ACTIVITIES

The GKIDS 2.0 platform is still available and is scheduled to close on June 12. Updates will be made during the summer and access for the 2020-2021 school year will begin July 6. Information for new schools opening in the fall will need to be provided by June 30.

NEW FOR KINDERGARTEN STUDENTS

Kindergarten students with significant cognitive disabilities will no longer be assessed on the GAA 2.0 beginning 2020-2021.

The Georgia Kindergarten Inventory of Developing Skills (GKIDS) 2.0 is a performance-based assessment based in learning progressions that is intended to provide teachers ongoing information about kindergarten students' developing skills. Georgia has the goal of supporting kindergarten teachers' use of GKIDS as a formative assessment, as information teachers use in real time to increase and accelerate student learning so that all students are ready for first grade.

Support is available during the assessment to ensure that all students have an opportunity to show what they know and can do allowing, to the extent that it is possible, the assessment to be invisible to students. Common classroom materials and manipulatives rather than a standardized set of materials and manipulatives during assessment with GKIDS 2.0 allows teachers to assess student performance during naturally occurring instruction, record student performance in an online platform, and generate a variety of reports for instructional planning, report cards and/or parent conferences.

Updates are currently being made to the training modules and will include guidance in support of all kindergarten students. The new modules will be ready July 2020.

Keenville



The Keens are beginning to prepare for summer activities and site maintenance. While the Keens are working behind the scenes to

prepare for a new school year, access to Keenville will be suspended for all districts.

It is important to note that access to Keenville is based on your current student rosters, and the end dates of your rosters determine the date that your access to Keenville will be suspended. For example, if your roster end date is May 25th, users will no longer have access to Keenville after that date, including access to district, school, and class data.

To ensure that all teachers have sufficient time to access and print an end-of-year parent report, data collection for the purpose of populating this report will end on May 15 for all districts. Parent reports including data for the month of May will be available beginning on May 18 and will remain available until the district's roster end date.

Between May 15 and your roster end date, students will still have access to Keenville games if assigned by the teacher. Student data will continue to populate in the dashboard for teachers and leaders, however, the parent report will not update after May 15.

Score Reports

The ACCESS for ELLs and Alternate ACCESS for ELLs Score Reports will be available in WIDA AMS on Thursday, May 7. Printed reports will arrive on Wednesday, June 24. Your district will receive a shipment with an affixed yellow label on the boxes containing ACCESS for ELLs and Alternate ACCESS for ELLs Score Reports.

In WIDA AMS, district-level users may view both district-level and school-level reports. School-level users may view school-level reports only. Please be mindful Test Administrators do not have access to these reports.

Post Reporting Data Validation Window

RETURN OF MATERIALS

STCs may return GAA 2.0 materials to Questar unless local guidance prohibits access to needed work sites or performance of requisite tasks (e.g. collecting and packaging test materials). It is understood that many

boxes may not have been opened by staff or distributed to schools. If boxes are unopened, it is not necessary to unseal them at this time, except for the materials box marked "Box 1." This box contains the return kits and labels.

CHANGE IN ASSESSMENT REQUIREMENTS

Kindergarten students with significant cognitive disabilities will take GKIDS during the 2020-2021 school year. Next year, the Georgia Alternate Assessment 2.0 will be administered to eligible students in grades 3-high school. Additional information and training will be provided in the coming months to ensure a smooth transition with the change to GKIDS 2.0 for all kindergarten students with significant cognitive disabilities.

Georgia Milestones Assessment System

Scoring and Reporting

Preliminary Spring Mid-Month EOC assessment data are currently available in eDIRECT. All students who were assessed during the Spring Mid-Month EOC administration should be included in the data files at this time.

Currently, only preliminary data files and reports are available. Typically, Spring Mid-Month data are aggregated with Spring Main data, and are, therefore, reported in "Final" form after the Spring Main data have been collected and reviewed for accuracy. Even though the Spring Main testing window was cancelled, final reports and data files will be available in eDIRECT and/or the MyGaDOE Portal according to the regular schedule provided. Due to the cancellation of the EOC Spring assessment window and the relatively low numbers of students who participate in Spring Mid-Month assessments, the Content Area Summary Report and the All Populations Summary Report will *not* be provided. For the same reasons, comparison data for the

school, system, and state will *not* appear on the final Spring Mid-Month ISRs. Therefore, the final versions of the data file, ISRs, and Class Rosters that you will receive in July will look similar to the preliminary versions now posted.

Print copies of the ISRs and student labels will be shipped to districts according to the schedule provided. Please share individual student results with students, teachers, and parents as circumstances permit.

Enhancements Beginning 2020-2021

There will be several Georgia Milestones enhancements beginning in 2020-2021! These changes are meant to reduce time spent on summative testing, allowing more time for instruction and formative feedback. However, these updates do not substantively change the Georgia Milestones test design. Students will continue to have the same, but shortened, testing experience. Year-to-year comparability of results will not be impacted.

To reduce the amount of time students spend on end-ofyear testing, we will be replacing all constructed response items with technology enhanced items in mathematics. We will also replace some constructed response items with technology enhanced items in English language arts. However, the Reading and Evidence Based Writing and Narrative Writing prompts will remain unchanged. We are also reducing the total number of points in science and social studies, reducing field test positions, and eliminating norm-referenced items in all content areas.

One of the benefits of our state utilizing online testing is that we have been able to effectively use technology enhanced items to elicit evidence of student learning in new ways, based on the intent of the standards. Replacing constructed response items with technology enhanced items maintains the quality of assessment while reducing testing and score return times. We estimate that these changes will save approximately 30 minutes for the ELA assessment and 40 minutes each for the mathematics, science, and social studies assessments.

We will continue to provide updates and guidance to the Georgia Milestones enhancements and reduced time spent on testing in upcoming trainings.

Software Updates for Central Office Services and INSIGHT

Please be sure your Technology Coordinators are aware of the updates for Central Office Services (COS) SD to version 4.x and DRC INSIGHT to version 11.x.

- DRC goes live with COS-SD v4.x for all devices on June 25. The COS SD should be available with Internet access and not in sleep mode to allow for an automatic update between midnight and 5 a.m. This will allow for the use of the COS application in the DRC INSIGHT Portal for initiating updates to the COS-SD.
- An updated version 11.x of the DRC INSIGHT app for iPads will be available overnight June 25 in the Apple App Store.
- Please ensure the iPads you use for WIDA/Milestones testing have version 11.x of the DRC INSIGHT app installed.
- If your iPads are not on version 11.x, you will need to manually update them to this new version either one-by-one via the Apple App store or deployment file via MDM software.
- The new DRC INSIGHT version 11.x for Chromebooks will be available overnight on June 25.


Refresh of DRC INSIGHT Portal Central Office Services


DRC is refreshing the look of the DRC INSIGHT Portal Central Office Services (COS) application. The updates will be made available overnight on June 25. The principal goals for the enhancement are to:

- Deliver an easier and more intuitive user interface,
- Enhance accessibility compliance,

- Build on the framework for evolving DRC INSIGHT Portal applications, and
- Remove references to the Testing Site Manager (TSM) and Device Toolkit (DTK).

The updated COS Dashboard also offers enhanced filtering and searching of a site's available COS Configurations. Also, note the removal of the reference to **Device Toolkit** from the page, and **Add Configuration** is now a button in the upper right corner of the page rather than a separate tab.

Although students will not be receiving an updated Lexile range reported through Georgia Milestones this spring, Georgia students and educators who wish to use the Lexile framework to find recommended reading material may visit the Lexile Hub's Find A Book tool to receive an updated Lexile range and associated reading lists at any time. Educators may also refer to the guidance on the Georgia Standards website for curating recommended reading lists, and other reading resources available with our Get Georgia Reading partners.

In addition, the Lexile Hub includes information regarding the <u>Summer Math Challenge</u> allowing math practice at home over the upcoming summer months.

NAEP/NCES

The 2021 testing is scheduled for January 25 to March 5, 2021. Selected schools and districts will be notified later this summer. Grades 4 and 8 will be tested in math and reading for state results, and grade 8 will be tested in civics and U.S. history as part of the national sample.

The national results from the 2018 civics, geography and U.S. history were recently released. A few notable results include:

- Comparison is between 8th grade student tested in 2014 to 8th grade students tested in 2018
- Average scores were lower overall in geography and U.S. history
- No significant change in the civics score
- The White-Hispanic gap has narrowed over time in civics and geography
- The White-Black gap has narrowed over time in geography

Accountability Update

Georgia has received an assessment and accountability waiver from the U.S. Department of Education (US ED) for the 2019-2020 school year, which means there will be no 2020 CCRPI. However, the 2020 4-year cohort graduation rate and the 2019 5-year cohort graduation rate must still be calculated. The following are updates regarding each of the CCRPI tools and applications. Considering the current circumstances, please remember that the accountability team will do everything possible to support you, and we are committed to remaining flexible and open to your needs.

The Live Portal Data Verification in the MyGaDOE CCRPI portal currently displays demographic data for each school. The 2020 4-year graduation cohort data file will be available in the tool soon. Information in the tool is updated nightly, based on Student Record uploads made by districts. Any errors must be corrected in Student Record before collections are certified by the district superintendent in June.

The **Assessment Matching Application** is currently available with national assessments (lagging data for the 2019 school year) and Winter EOC.

The **Non-Participation Application** will be available this summer with ACCESS data only, as the ACCESS window was complete before schools began closing. This will allow districts to provide reasons for non-participation on the ACCESS to be used by Title III.

The **Cohort Withdrawal Update Application** will be available this summer. Once the list of students in the cohort displays in the Live Portal Data Verification around mid-May, districts should begin to collect documentation for the application as best they can.

Summer Graduate Collection will be available this summer. US ED allows four school years plus one summer for a student to graduate with his or her cohort. Thus, any student who completes coursework over the summer without enrolling in the new school year can be counted as a graduate in the summer collection.

The GAA 1% Participation Application, available in late summer or early fall, will be updated to reflect that the GAA 2.0 was not administered this spring. Districts will be required to enter information needed for 2021.

which includes estimated participation and documentation of actions taken to support GAA 2.0 identification and administration at the local level.

As best they can, school staff should be collecting documentation now for districts to utilize in completing the applications. Look for an email with the closing date, user guide, and training webinar link for each application

as it opens. If you are not responsible for completing an application, be sure to forward the email to the appropriate staff in your district.
