The test site administrator orders the assessment, completes the on-line Testing Agreement, and completes test site setup. Assists instructors with completing and loading student rosters Prints and distributes usernames and passwords to students on test day (Note: Usernames and passwords should never be given to instructors for distribution.) Assist students with accessing the system on test day. Prints and distributes Coaching Reports and Certificates. Provides assistance to instructors and reporting authorities needing to download testing data or print testing-related reports. <p>The test site administrator can proctor the assessment, or he/she can designate other persons to proctor the exam under his/her supervision.
