Ga Parent Mentor Partnership Application for Participation in FY25






Ga Parent Mentor Partnership (GaPMP)

- The GaPMP is supported by the Division for Special Education Services and Supports (DSESS).
- Parent Mentors are hired by local school districts to work with families, school teams, teachers, and the community.
- The goal is to build a bridge of communication between home and school that leads to more successful outcomes for students.
- Although the GaPMP is under the leadership of the DSESS, the Parent Mentor's agenda is locally driven.



Facilitated IEP Meeting Reminders

A facilitated IEP Team meeting is the same as any other IEP Team meeting, except that a facilitator joins the meeting, and it is optional. Additional information to share with families and with your staff can be found here:

IEP-Facilitation Information

- 1. Make sure to use the correct form. There are two forms.
 - □ Statewide Application
 - □ State Schools Application
- 2. The District should contact GADOE at least **7 to 10 days** prior to the meeting date.



Facilitated IEP Meeting Reminders

- 3. To process the application for the meeting the DOE needs the following items completed:
 - □Completed Application(which includes all signatures from the Special Education Director and the Parent)
 - □Notice of Meeting with the time of the meeting, location, and date
- 4. Email the completed application to the SPEDHelpdesk@doe.k12.ga.us and label the email **FIEP** Request.
- 5. Remember the LEA or the Parent can make the request.
