**\*Guidance for the TFI Walkthrough:**

Tier I TFI: A minimum of one TFI Walkthrough, with Product Book Review included, is required for the 2022-2023 school year, however it is recommended that a Walkthrough is conducted prior to each TFI meeting to better inform the PBIS team.

**\*\*Guidance for the SAS:**

A minimum of one Self-Assessment Survey (SAS) administration is required for the 2022-2023 school year. Administering it early in the year is recommended to help inform action planning. It is also recommended that at least 80% of staff complete the SAS for reliable results.
