

## **Exhibit B – Flexibility Component of Contract**

### **For the Rome City School District**

Under O.C.G.A. § 20-2-80 and SBOE Rule 160-5-1-.33, The Rome City School District is seeking flexibility for all its schools from the following state statutes and associated rules in exchange for greater accountability (as outlined in the IE2 Partnership Contract) over the life of a five-year contract which allows for seven years of flexibility between the Rome City School District Board of Education and the Georgia State Board of Education, except as prohibited in O.C.G.A. § 20-2-82(e).

- Common Minimum Facility Requirements to the extent that square footage requirements are not waived in situations where the health and safety of students is jeopardized and only after consultation with Georgia Department of Education Director of Facilities Services, and to the extent that the waiver does not affect capital outlay funding determinations (O.C.G.A. § 20-2-260)
