The Parent Engagement Program is provided by the Georgia Department of Education (GaDOE) to assist and assure that Title I, Part A Parental Involvement regulations are met with meaningful and strategic actions to build parent capacity in schools and school districts under the law. Schools and districts are responsible for ensuring effective involvement of parents by developing and sustaining partnerships to build parent capacity to attain students' high academic achievement.

Program Implementation

The Parent Engagement Program is focused on working with partners in local school districts and the community to provide parents with the best opportunities and resources to help their children succeed in school.


To achieve this goal, the Parent Engagement Program:

Develops and delivers communications to parents and families on the factors that influence student success

Creates collaborative partnerships with external organizations and agencies that support parent and family engagement initiatives to provide needed services, supports, and resources to school districts and parents

Provides technical assistance, trainings, materials, and professional development opportunities for parental involvement strategies and compliance as mandated by law to district and school administrators, parent involvement coordinators or liaisons, and other family engagement professionals

Collaborates and coordinates plans with other GaDOE programs to ensure that parent engagement is a focus of various initiatives across the agency and that school districts are equipped with knowledge of these programs to share with parents and their children

Framework

The Georgia State Board of Education adopted Georgia's first Resolution and Statement on Parent Engagement. The resolution, along with the National PTA Standards for Family-School Partnerships, are the guiding foundation for local school officials to develop local school and district plans and policies providing a framework for parent-school-community partnerships.

National PTA Standards for Family-School Partnerships

The Georgia Department of Education has adopted the National PTA Standards for Family-School Partnerships as the state's parent engagement model for what parents, schools and communities can do together to support student success.

Georgia's Resolution and Statement on Parent Engagement


The Georgia State Board of Education and the Georgia Department of Education recognize that the partnerships between parents, schools, and communities must be viewed as equal with shared responsibilities, but schools must take the lead in developing and sustaining these collaborative partnerships to ensure maximum effectiveness. Each partner, however, has a role to play, as clearly outlined in the resolution and statement, and local school officials are strongly urged to use them as a guide in developing local school and district plans and policies.



Parent Involvement Coordinators

The Georgia Parent Involvement Coordinator (PIC) Network is a support system and a vehicle to provide ongoing communication and professional development to over 900 PICs throughout the state. As advocates for parents in their schools, PICs offer a variety of educational programs, activities, and resources to assist parents in helping their children achieve their maximum academic potential.

Parent engagement professionals participate in professional development meetings that are held within their region according to the map below. These meetings connect PICs from across the state and provide an opportunity to collectively share ideas, best practices, learn about new parent engagement resources and strategies, and participate in technical assistance for parent involvement compliance. The GaDOE's Parent Engagement Program supports the work of PICs by sending a monthly announcement to the PIC Network, promoting PIC Local Learning Communities, providing webinars on parent engagement requirements and strategies and developing various materials and resources.
