<b>Description</b>	<p>Self-directed Computer-Based Instruction includes online course, locally installed courseware and courseware accessed remotely.</p> <p><u>All instruction is by the computer program.</u> <u>The software will give the grade for the student's performance.</u></p>	<p>Facilitated Group Online Learning Computer Based Instruction includes online course, locally installed courseware and courseware accessed remotely.</p> <p><u>All instruction is by the computer program.</u> <u>The software will give the grade for the student's performance.</u> The facilitator is there to monitor and help the student, but does not deliver direct instruction.</p>	<p>Blended Learning - A formal education program that leverages both technology-based and face-to-face instructional approaches, that include an element of online or digital learning, combined with supervised learning time, and student led learning, in which the elements are connected to provide an integrated learning experience; and in which students are provided some control over time, path, or pace. Teacher will give the grade.</p>

<b>Description</b>	Direct Instruction with certified teacher, using computer - based instruction for GAVS virtual courses. Primary Teacher is the teacher of record.	Direct Instruction with certified teacher, computer - based instruction includes online, distance learning, or virtual courses. Primary Teacher is the teacher of record.	Classroom Teacher that uses courseware or online resources and tools as part of instruction. The classroom teacher provides direct instruction and is the teacher of record.

<b>Notes</b>	If the teacher has the appropriate credentials and the program criteria are met, it is preferred that the course number for the program instruction type (i.e. XX.1, XX.2, etc) is reported.
