SUBJECT: ACCESS for ELLs (ACCESS 2.0) 2015-2016 Administration Update

In 2015-2016, Georgia will begin administration of a newly developed ACCESS for ELLs (ACCESS 2.0) summative assessment. The new program will include an online mode for test administration that will replace the former paper-based version of ACCESS for ELLs for Grades 1-12. A paper-based assessment will continue to be available for students who may have a disability that requires paper-based testing. Additionally, GaDOE will assist systems in gaining paper-pencil test materials for schools that are unable to test all English Learner (EL) students online due to technology limitations. Importantly, please note that there will be no changes, in mode or otherwise, to the Alternate ACCESS for ELLs in 2015-2016.

As with the previous version of ACCESS for ELLs, the tasks on the new summative assessment will attempt to replicate the kinds of communicative situations (and the language needed to be processed or produced within them) that might be encountered in different school contexts. Each assessment item and task will target at least one of the five WIDA English Development Standards (ELDs):

- Social and Instructional Language
- Language of Language Arts
- Language of Mathematics
- Language of Science
- Language of Social Studies

STATE TESTING WINDOW:

Georgia's 2015-2016 ACCESS for ELLs testing window appears below. You will note that it remains similar to the window of previous years.

• January 19, 2016 – March 4, 2016

GENERAL INFORMATION:

ACCESS for ELLs will continue to assess each of the four language domains separately: Listening, Speaking, Reading, and Writing. WIDA recommends that students first take the Listening test and then the Reading test. Speaking and Writing may be taken in either order. Target administration times range from 30 minutes up to 60 minutes.

ONLINE MODE

- ACCESS for ELLs will assess (via the *online* platform) Grades 1-12 using the following **new** clusters: Grade 1, Grades 2-3, Grades 4-5, Grades 6-8, and Grades 9-12.
- The Writing domain for the online ACCESS for ELLs Grade 1 and Grades 2-3 forms will continue to be administered on paper. The same will be true for Grades 4-5 in 2015-2016.
- The *online* test is a staged, adaptive test, meaning students will progress through the test based on their performance.
 - Due to this adaptability, the *online* test will <u>not</u> require the tier placement of students in order to administer the test.
 - Note: In cases where the paper test is administered, schools must continue to identify the appropriate tier as in previous years. See below.
- Each student testing online will require a computer and headset <u>with microphone</u> for the Speaking test and headphones for the other domains. Detailed information about technology requirements is posted at this location: <u>https://www.wida.us/assessment/access20-tech.aspx</u>.
- The domains may be administered across multiple days in the manner that best works for scheduling purposes and the use of technology. However, a single domain may not be broken into separate administrations.
- The online platform will not have a limit on the number of students who can test at one time.
 - For Speaking, it is recommended that groups of 5-7 students (or fewer) test simultaneously so that headset microphones do not capture other voices. Students of different grades may test in the same room at the same time, but this is not required and schools/systems may wish to consider if this is appropriate for the students involved.

PAPER-PENCIL MODE

- Kindergarten will continue to be paper-based (only) in 2015-2016.
- The paper test in Grades 1-12 will include the following grade clusters: Grade 1, Grade 2, Grade 3, Grades 4-5, Grades 6-8, and Grades 9-12.
 - In 2016-2017, the paper test will be updated to have the same grade clusters as the online test.
- Tier placements are <u>required</u> for paper testing and the protocols will remain the same as previous years.

Note that additional details will be provided during our upcoming Fall Assessment Conference General Session and through multiple training resources and webinar sessions that will occur during the months of September 2015 – January 2016 (see below).

 - GTID (10-digit) must be used in the *State Student ID* field (District Student ID must be left blank)
