Please note that sessions marked with an asterisk (\*) are anticipated as live redeliveries of a session of the same name that occurred on a previous date.

The majority of these events are required pre-administration trainings – the contents of which shall be redelivered to local School Test Coordinators and others. In addition, there are sessions designed to assist System Test Coordinators with the ordering of materials, preparations for online test administration, and other critical tasks. Representatives from the Georgia Department of Education, and in some instances GaDOE contractors, will conduct the workshops. Any additional sessions, or changes to this schedule, will be announced by email to System Test Coordinators.

All System Test Coordinators are expected to attend one of each set of webinars noted above. Each webinar will be recorded and available for participants who are unable to attend – but one must pre-register for the webinar to gain access to the recording. In most instances, the presentations will be posted on the GaDOE webpage for each specific assessment program.

#### IMPORTANT WEBINAR PLATFORM INFORMATION:

GaDOE's webinar platform requires pre-registration for each session. System Test Coordinators will receive the notification, and a link to use to pre-register for the webinars above, in advance through email. After pre-registering, System Test Coordinators will receive a unique link to use to log-in at the appointed time. Pre-registration will also generate automatic reminders prior to the session. System Test Coordinators will be able to share the invitation with others in their system that would benefit from a session. Additional attendees will be required to pre-register as well – and will receive their own unique URL after doing so. Recordings of each session will be available, but only for those who pre-register.

### Please note the following details:

• After pre-registering, you will receive a unique link to use to enter the actual webinar session on its scheduled date/time. Your pre-registration will also generate automatic reminders (that will be sent to the email address you provide) prior to the session.
