SUBJECT: 2019 System Test Coordinator (STC) Fall Conferences

In preparation for the 2019-2020 school year, the Assessment Division of the Georgia Department of Education (GaDOE) will again be conducting our annual System Test Coordinator (STC) Fall Conferences during the months of August and September 2019.
