SUBJECT: 2021-2022 Assessment Training Schedule

The Assessment Division of the Georgia Department of Education (GaDOE) will host various online training webinars over the course of the 2021-2022 school year.

Effective September 1, 2021, the GaDOE will utilize Microsoft Teams (in place of GoToWebinar) for all webinar presentations facilitated by the Assessment Division. All attendees must preregister for all training sessions (required and optional) through links provided in the monthly Assessment Update newsletters posted to the For Educators site. Links to the recordings will be shared with attendees. STCs are reminded to refer to the Assessment Update posted monthly to the For Educators website for regularly updated guidance and policy related to all assessments.

Of note, the ACCESS for ELLs 2.0 and Alternate ACCESS trainings will primarily take place through the WIDA 2021-2022 training schedule posted at <a href="https://wida.wisc.edu/">https://wida.wisc.edu/</a>. These WIDA training sessions will be included and announced to STCs through the monthly Assessment Updates. In September, all ACCESS for ELLs and WIDA Screener training courses will migrate to WIDA's learning management system, Canvas.
