SUBJECT: 2017 System Test Coordinator (STC) Fall Conference

In preparation for the 2017-208 school year, the Assessment Division of the Georgia Department of Education (GaDOE) will again be conducting our annual System Test Coordinator Fall Conference during the months of August and September 2017.

The purpose of these sessions is to provide important information necessary for the successful administration of the 2017-2018 Georgia Student Assessment Program. All sessions will be held via webinar. The links for each session can be found below in this memorandum; no password is needed. - Session: Fall Conference Part 2/Chief planning considerations for the assessment district and school year (Select Aug. 31 or Sep. 7, 2017)
 - o Important information regarding planning/preparations for secure and successful test administrations will be discussed during this session.
- Session: Fall Conference Part 3/Accessibility and Accommodations (Select Sept. 14, 2017)
 - This session will focus on issues of accessibility and accommodations for special populations.

We encourage all System Test Coordinators to attend the live session noted below if schedules permit. If not, a recording link will be sent to all who pre-register.

System Test Coordinators are welcome to invite other interested colleagues (e.g., Curriculum, Special Education, or Title III Coordinators).
