Registration is Open for the Federal Programs Conference: District and School Leaders Improving Outcomes for Georgia's Students!

Registration for the Georgia Department of Education's Federal Programs Conference: District and School Leaders Improving Outcomes for Georgia's Students is open. This is a collaborative initiative from the Offices of Federal Programs, School and District Improvement, Teaching and Learning, Whole Child Supports, Financial Review, Assessment & Accountability, and Rural Education and Innovation.

District and school leaders will receive information to assist with plans for coordinating federal funds in FY25 and supporting newly identified CSI and TSI schools. Local Educational Agencies (LEA) participants should include representatives working with the Every Student Succeeds Act (ESSA) grants, the Individuals with Disabilities Education Act (IDEA) grants, and selected

instructional personnel. Principals at newly identified Comprehensive Support and Improvement (CSI) schools, their direct supervisors, and the district point of contact for Targeted Support and Improvement (TSI) and Additional Targeted Support and Improvement (ATSI) schools are required to attend.

This conference will be an in-person event with a modified virtual option. LEA staff not able to join in-person can register for the free live-stream of the general sessions only. All workshop recordings will be available in the GaDOE PL Events catalog after the conference. Research Highlights from the National Center for Special Education Research

The Institute for Education Science's (IES) National Center for Special Education Research (NCSER) funds research to expand the knowledge and understanding of learners with and at risk for disabilities, from infancy through postsecondary settings.

"The Importance of Collaboration and Support to Improve Working Conditions for Special Education Teachers" takes a deeper dive into one issue discussed during NCSER's February 2023 Special Education Teacher Workforce technical working group — lack of collegial and leadership support as a contributing factor to teacher burnout and attrition. It also summarizes some of the NCSER-funded research on supporting special education teachers.

- -Adaptive "Letters to Santa" templates sent before the event for students to complete with assistance as needed
- -Adaptive Holiday Visual Recipe Instructions for Cookie Decorating
- -Adaptive "SANTA" Bingo Cards
- -Sensory Room/Calm Down Station Availability
- -Many invaluable "Elves" and other volunteers who gave their time and heart to this event!

Mrs. Riley Troili, who started the SEA in August 2023, stated, "I am ecstatic at the turnout and more than appreciative of all who volunteered their time to make this possible. Sometimes our students are not invited to parties and similar events, or they cannot handle the sensory overload, or they may feel awkward in those settings. Mrs. Moore and I hoped that this "SEAsonal FRIENDSmas Celebration" would be a day that all of these students would feel comfortable, loved and included." This event provided all of this and so much more! Thank you, Riley, and all volunteers for supporting students with disabilities!

Practice Pointers – Individualized Education Program (IEP): Supplemental Aids and Services / Support for School Personnel

Supplemental aids and services should include supports that are provided in general education classes or other education-related settings to enable children with disabilities to be educated with nondisabled children to the maximum extent appropriate as well as participate in nonacademic and extracurricular activities as determined by the IEP Team. Examples of these supports include tutoring, adult assistance, note-taking, peer helper, pre-teaching/re-teaching or reinforcing concepts, behavior intervention plan, point sheet, assigned seating, etc. Some accommodations used for instruction may also be considered a supplemental aid and service. In comparison, supports for school personnel should be included when training or other supports are being provided to local educational agency (LEA) staff regarding a specific child's need. Examples of these supports may include

training on an assistive technology device and/or service, a workshop on a content area or disability area, crisis prevention training, behavior management techniques, etc.
