The Georgia Vocational Rehabilitation Agency (GVRA) is pleased to announce the availability of the Bud McCall Post-Secondary Vocational Rehabilitation Grant, which allows up to \$17,725 to be awarded annually to eligible students with disabilities seeking post-secondary and other Vocational Rehabilitation (VR) services. Candidates for the grant must have an Individualized Education Plan (IEP) or 504 Plan. To be eligible, they also must have a permanent disability that results in a substantial impediment to employment and be eligible for GVRA services. To apply, visit the GVRA website.

Jennifer Popkin is the Special Education Director for Wayne County Schools and has been in the field of education for 26 years. Ms. Popkin began her career as a teacher of students with moderate, severe, and profound disabilities at Burroughs-Molette Elementary in Glynn County. Ms. Popkin's career has also included being a member of the District Assistive Technology Team, a middle school teacher, an autism teacher, an Autism and Direct Instruction Specialist, a coach of all special education reading, Program Specialist for Coastal GLRS with First District RESA,

Wayne County Library Media Specialist, Assistant Director of Special Education, and in March 2023, Ms. Popkin assumed the role of Director of Special Education.

Sharing that she is blessed to have been a part of many different teams along the way and how thankful she is for the lessons and mentors that she had in each role, Ms. Popkin shared "There is not a day that goes by that I don't think of a dear friend and mentor, Maggie Boozer, who coached and supported me when I was the Reading and Autism Coach in Wayne. Her coaching was always child-centered, keeping the whole child in mind. While we were advocating for students, she always cared for the adults in the building, too. She formed relationships with staff and students alike. She could get the most challenging child to do whatever she wanted them to do because she began with relationships. I learned from her that my actions will let people know how much I care. I hope to do the same for those around me. It is not as easy as she made it seem. My hope is that if I continue to form relationships with staff and families, then I will be a "Maggie" for others around me."

Ms. Popkin has a love for learning and her happy place is the beach as she loves to drive to St. Simons Island every chance she gets. Married for 27 years to her husband David, the Popkin's have three children: Jacob, Mia, and Maura along with two grand dogs, Joe, and Penny. While Jacob manages the family restaurant in Jesup, Ms. Popkin shares, "If you ever come our way, stop by Damon's Famous Fingers and Wings, and tell them I sent you!"

District Highlight: Bleckley County Schools




Mrs. Riley Troili and Mrs. Scarlett Moore at Bleckley Elementary in Cochran, GA, selected a wonderful

Practice Pointers – Individualized Education Program (IEP) Team Excusals: Timeline for Notification

QUESTION C-5: IS THERE A SPECIFIC TIMELINE IN THE INDIVIDUALS WITH DISABILITIES EDUCATION ACT (IDEA) FOR

PUBLIC AGENCIES TO NOTIFY PARENTS OF A REQUEST TO

EXCUSE AN IEP TEAM MEMBER FROM ATTENDING AN IEP TEAM MEETING?

The Office of Special Education and Rehabilitative Services (OSERS) has emphasized in a Questions and Answers Document that under the Individuals with Disabilities Education Act (IDEA), neither the IDEA nor its implementing regulations specify a time period in which a public agency must notify parents of a request for an excusal. In public comments on the proposed Part B regulations, the United States Department of Education (USED) was asked to specify a timeline, through regulations, in which a public agency must notify parents of requests for excusing IEP Team members from attending IEP Team meetings. In declining the commenter's request to regulate, USED noted that Part B of the IDEA does not specify how far in advance of an IEP Team meeting a public agency must notify a parent of the public agency's request to excuse an IEP Team member from attending the IEP Team meeting. Further, Part B of the IDEA does not specify, when the parent and public agency must sign a written agreement that the IEP Team member's attendance is not necessary, consistent with the regulations, or when the parent and agency must provide written consent regarding the IEP Team member's excusal consistent with the regulations. USED also explained that requiring the reguest for excusal or the written agreement or written consent to occur at a particular time prior to an IEP Team meeting would not account for situations where it would be impossible to meet the timeline (e.g., when an IEP Team member has an emergency). Thus, requiring specific timelines could impede Congressional intent to provide additional flexibility to parents in scheduling IEP Team meetings, as reflected in the IDEA.

Georgia Vocational Rehabilitation Agency (GVRA): Bud McCall Post-Secondary Vocational Rehabilitation Grant

The Georgia Vocational Rehabilitation Agency (GVRA) is pleased to announce the availability of the Bud McCall Post-Secondary Vocational Rehabilitation Grant, which allows up to \$17,725 to be awarded annually to eligible students with disabilities seeking post-secondary and other Vocational Rehabilitation (VR) services.

Candidates for the grant must have an Individualized Education Plan (IEP) or 504 Plan. To be eligible, they also must have a permanent disability that results in a substantial impediment to employment and be eligible for GVRA services. To apply, visit the GVRA website.

GVRA's announcement of the grant follows policy changes that removed the financial-needs assessment as a requirement for individuals with disabilities seeking post-secondary opportunities. The changes became effective on January 1. In addition to removing that barrier, GVRA increased the maximum grant amount to match funding offered through the Pell Grant. The Bud McCall Grant provides up to \$7,395 for tuition, \$9,430 for maintenance (room, board, and meals), and \$900 for books annually.

The Bud McCall Grant is named in memory of the first-born son of former State Representative Tom McCall and Georgia Vocational Rehabilitation Services Board Member Jane McCall, whose love for others served as an inspiration to his family, friends, and the entire community.

Important Budget Announcement: FY23 Maintenance of Effort Compliance Results Now Updated in the GaDOE Portal

The FY23 Maintenance of Effort (MOE) Compliance results are now updated. The MOE results can be viewed in the GaDOE Portal by going to Special Education Programs > Special Education MOE. LEAs that do not meet compliance may take allowable exceptions, if applicable, to reduce effort. Please see the Exceptions to MOE Requirement document. If your LEA determines there are applicable exceptions, please complete and return the form to your Budget Specialist with supporting documentation by March 14, 2024. **This is the final deadline**. Reconciliations must take place before this deadline. Please begin the reconciliation process as soon as possible. This process can be time-consuming and may require the support of your Finance Office. If eligible exceptions are not determined, repayment may be required. Please note, that budget amendments will be delayed until MOE Compliance is met.
