Just a reminder about the Federal Programs Conference scheduled for February 13-14, 2023 at the Georgia International Convention Center. Registration is still open. Conference information and registration is available. Join the offices of Federal Programs, School and District Improvement, Teaching and Learning, Whole Child Supports, Financial Review, Assessment & Accountability, and Rural Education and Innovation for two days of training and information sharing.

District and school leaders will receive information to assist with plans for coordinating federal funds in FY25 and supporting newly identified CSI and TSI schools. Local Educational Agencies (LEA) participants should include representatives working with Every Student Succeeds Act (ESSA) grants, the Individuals with Disabilities Education Act (IDEA) grants, and selected instructional personnel. Principals at newly identified Comprehensive Support and Improvement (CSI) schools, their direct supervisors, and the district point of contact for Targeted Support and Improvement (TSI) and Additional Targeted Support and Improvement (ATSI) schools are required to attend.

This conference will be an in-person event with a modified virtual option. LEA staff not able to join in-person can register for the free live-stream of the general sessions only. All workshop recordings will be available in the GaDOE PL Events catalog after the conference. Registration will close on February 1, 2024, or when capacity is met. If space remains after February 1, we will reopen for general registration.

To ensure all LEAs have access to this conference, we are limiting registration by LEA as follows:

- -Small Districts (3,999 students and below) = 5 registrants
- -Medium Districts (4,000 19,999 students) = 8 registrants
- -Large Districts (20,000 75,000 students) = 10 registrants
- -Extra Large Districts (Above 75,000 students) = 14 registrants

# QUESTION 17: HOW DOES THE ENDREW F. DECISION IMPACT PLACEMENT DECISIONS?

The United States Department of Education (USED) has stated in a Questionand-Answer (Q&A) Guidance Document, that the Endrew F. decision is important because it informs our efforts to improve academic outcomes for children with disabilities. Consistent with the decision in Endrew F., USED continues to recognize that it is essential to make individualized determinations about what constitutes appropriate instruction and services for each child with a disability and the placement in which that instruction and those services can be provided to the child. There is no "one-size-fits-all" approach to educating children with disabilities. Rather, placement decisions must be individualized and made consistent with a child's IEP. USED also notes that placement in regular classes may not be the least restrictive placement for every child with a disability. The IDEA Part B regulations specify that each public agency must ensure that a continuum of alternative placements (including instruction in regular classes, special classes, special schools, home instruction, placement in private schools, and instruction in hospitals and institutions) is available to meet the needs of children with disabilities for special education and related services.

## Important Budget Announcement: High-Cost Fund for Special Educations Services Grant and Grant for Residential & Reintegration Services

The High-Cost Fund for Special Education Services Grant and Grant for Residential & Reintegration Services submission period opened January 1st. ## Important Budget Reminder: Excess Cost Calculation Submission

The Excess Cost Calculation Portal is now open for submissions. The Special Education Excess Cost Calculation, which is part of the local district determination's Timely and Accurate Data Submission Report, is due by January 31, 2024. This submission must be entered into the Consolidated Application and has a two part sign-off for the results and base calculations. Please plan accordingly as both parts must be submitted by the due date. Resources for the calculation can be found on our budget page here. ## Language and Literacy in Preschool Trainings Available

Join us for an in-person, day-long workshop designed for teachers, paraprofessionals, and related service providers of preschool students with disabilities. This session will focus on Language & Literacy that incorporates instruction on phonological awareness, concepts of print, and alphabetic

knowledge. Information presented will be based on literacy research and how literacy instruction in the early years impacts reading in elementary school and beyond. Participants will learn to identify a variety of methods for differentiating instruction for all children with a focus on intervention for students with characteristics of dyslexia.

This Best Practices Training, led by staff from Georgia State University's Department of Early Childhood and Elementary Education, provides professional development tools needed to keep Georgia educators at the forefront of current research and field-tested classroom methodology. Each attendee will receive two preschool books with coordinating activities for use in the classroom.
