Install this release <u>after</u> completing the March 2020 payroll(s). Install this release <u>before</u> executing F4 – Calculate Payroll and Update YTD for the April 2020 payroll. Be sure to close out any vendor / accounts payable check run prior to installing this release.

# Section A: Overview of Release A1. PCGenesis System Enhancements

### A1.1. Expiration Date for Windows Server 2008 and 2008\_R2

This is an important announcement concerning PCGenesis compatibility with the Windows Server operating system. As of June 30, 2020, PCGenesis will no longer support the Windows Server 2008 and 2008\_R2 operating system, or any earlier operating systems. Please provide this information to your school system's IT staff!

Please be aware that the GaDOE has <u>decommissioned</u> all of their 2008\_R2 servers as of January 2020 making it nearly impossible to support school systems still running PCGenesis on the 2008 versions of Windows Servers. The Ga DOE will no longer allow a Windows Server 2008 operating system on the DOE network. The GaDOE highly recommends that all PCGenesis sites still running **Windows Server 2008 and 2008\_R2** should <u>immediately</u> begin the process of upgrading their PCGenesis server.

This announcement is made with the knowledge that the end-of-support date <u>has passed</u> for the **Windows Server 2008/2008 R2** versions. If you have questions, please contact your Microsoft support team.

Microsoft extended Support for Windows Server 2008/2008 R2 ends January 14, 2020

Today, the PCGenesis development team will continue to try and support school districts running the Windows Server 2008 operating system through June 30, 2020. However, school districts that continue to use unsupported Microsoft software past the end-of-support dates, do so at their own risk with the full knowledge that PCGenesis software does <u>not</u> provide the necessary security enhancements. PCGenesis data is vulnerable unless security updates are provided by Microsoft to ensure system integrity.

PCGenesis will continue to support Windows Server 2012 and 2016 until further notice. Server 2019 R2 64 bit and Windows 10 pro 64 bit have been successfully installed in many PCGenesis sites and are strongly recommended. The PCGenesis development team has certified that Windows Server 2019 R2 is a supported operating system for the PCGenesis software.

#### A1.2. PCGenesis Reorganization Daily Task

Several obsolete reorganization batch process files are being deleted in release 20.01.00. These "old" reorganization processes do not create a **PCGenesisDBX.BAK** backup of the *SQL Server* database, and are no longer supported by the Ga DOE. The following bat files are being deleted:

- K:\Backup\reorg.bat
- K:\Backup\reorgX.bat

Please inform your IT staff that the above jobs have been deleted, and that these bat files should <u>not</u> be restored to your production system. The above bat files are obsolete. Please refer your IT staff to Section B: PCGenesis Backup / Reorganization / Restore, Topic 2: How To Schedule the PCGenesis Reorganization Job at the following Ga DOE website for instructions on setting up the correct reorganization batch job:

The correct reorganization task is **K:\Backup\PCGREORG.BAT**. The PCGenesis reorganization task creates a copy of **K:\SECOND** as **K:\SECONDX** and reorganizes all indexed files. The reorganization task also creates a copy of the *SQL Server* PCGenesis database (**PCGenesisDB**) as **PCGenesisDBX.BAK**. The scheduled task creates a recap report which will allow the user to verify that the reorganization process has completed successfully. The recap report will be created in the **K:\UCTPRINT\#SPLPRT** directory with the filename *REOGnnnn*. If the General Ledger is out of

If the reorganization batch job has not run successfully for at least three days, the logon screen will display an error message in red, as shown below. If this message appears on the PCGenesis logon screen, inform your IT staff immediately!

The PCGenesis administrator must ensure that the reorganization task runs successfully every day. Any failure that affects the integrity and availability of PCGenesis data is unacceptable. The PCGenesis reorganization task improves PCGenesis reliability and data integrity by reorganizing all PCGenesis indexed files. The reorganization task also creates a daily restore point that remains on the PCGenesis server for quick access. This restore point often provides the Ga DOE Helpdesk with a quick and easy way to recover from a data issue.

# A1.3. Conversion of Account Master Description File to PCGenesisDB SQL Server Database Tables

The GaDOE is happy to announce a major upgrade of the PCGenesis. Release 20.01.00 continues the conversion of the PCGenesis data into *SQL Server* database tables. The migration of PCGenesis to a *SQL Server* database is a major undertaking, but a step that it is imperative to take for the longevity of the product.

Today, the PCGenesis data is stored in VISION files which are indexed, flat files, and are proprietary to *MicroFocus*. Nothing other than *MicroFocus ACUCOBOL* can access the data from VISION files. VISION files represent very old technology. *SQL Server* is a relational database management system (RDBMS). Relational databases are faster, more efficient and more powerful than VISION files. The database updated in this release is named *PCGenesisDB*.

In release 20.01.00, the *Account Master Description File* (K:\SECOND\FARDATA\**NAME**) is converted into the following database tables:

The Account Master Description tables represent the 10 "pieces" of the 30-digit account number. These account "pieces" correspond to the Yr Fnd F Prgm Fnct Objet Fcty B Addt'l fields of a general ledger account. The Account Master Description tables also provide the descriptions of the account number on various Financial Accounting and Reporting (FAR) system reports, and determines if the account number is valid when entered in PCGenesis.

Converting PCGenesis to a relational database management system (RDBMS) is a very, very big project. We estimate that it may take several years to convert the software. During that timeframe, major enhancements to PCGenesis will be very limited. However, legislative requirements will always be addressed even during the conversion process.

The PCGenesis database is in the following location for *Windows Server 2012 or 2016*:

- K:\PCGSQLdb\MSSQL13.SQLEXPRESSPCG\MSSQL\DATA\ PCGenesisDB.mdf
- K:\PCGSQLdb\MSSQL13.SQLEXPRESSPCG\MSSQL\DATA\ PCGenesisDB\_log.ldf

The PCGenesis database is in the following location for *Windows Server 2008 R2*:

- K:\PCGSQLdb\MSSQL11.SQLEXPRESSPCG\MSSQL\DATA\ PCGenesisDB.mdf
- K:\PCGSQLdb\MSSQL11.SQLEXPRESSPCG\MSSQL\DATA\ PCGenesisDB\_log.ldf

Why go to all the trouble of converting the old VISION data files? First, updating the data files allows us to implement far better transaction processing. Today, we have problems with data reliability. Today, if a posting process is interrupted because of a power failure, or network hiccup, half of the PCGenesis data files may be updated (for instance the RECEIPT file) and half of the files may not be updated (for instance the AUDIT file). This requires a data repair!!

Second, we can modernize the PCGenesis data structures and allow access to the data from programs other than COBOL programs. This means that as COBOL programmers retire, the data will be accessible to more modern programming languages such as C#, Java, Crystal Reports, etc., and a new generation of programmers will more easily take over maintenance of the product.

The upgrade to *MicroFocus Extend 10* in September of 2016 came with the ability to execute SQL code from within PCGenesis COBOL programs. This feature is called *AcuSQL*. Having *AcuSQL* bundled in with the *MicroFocus Extend 10* runtime allows the Ga DOE to make use of database technology at no extra cost. Industry standard database support is now included in the *MicroFocus Extend 10 ACUCOBOL* runtime product.

#### A1.4. Backup of PCGenesis Data

This information must be forwarded to your Technology Representative or you may not have everything you need for a successful restore of your PCGenesis production data.

Going forward, PCGenesis data will be split between files contained in the directory **K:\SECOND** and the new *SQL Server* database table located in **K:\PCGSQLdb**. Therefore, it is very important to backup **K:\PCGSQLdb** and **K:\SECOND** during the nightly backup. One directory cannot be backed up without the other directory, and they must be maintained together. To create a complete backup of the PCGenesis system, the two directories need to be backed up together.

With release 19.04.00, **K:\SECOND** cannot be restored without also restoring the **PCGenesisDB** database. These two entities must be kept in sync, otherwise the *Display Bank Balances* screen (F1, F8, F1) will not have correct data.

The following directories are needed for disaster recovery:

- K:\SECOND PCG payroll & financial data
- **K:\PCGSQLdb** The *PCGenesisDB* database for the PCGenesis production data, and the *VQueueDB* database for the *VerraDyne* print queue data
- **K:\UCTARCHIVE** Archived PCGenesis reports in pdf format
- **K:\UCTPRINT** PCGenesis report files currently in the print queue

**Prior** to running a backup of the **K:\PCGSQLdb** directory...

- School districts must <u>stop</u> the *VerraDyne Queue Service* and the *SQL Express* services for the backup to successfully run to completion.
- The following commands should be entered in the command prompt for *Windows* or added to the backup bat file to <u>stop</u> the services:

NET STOP VQueueService NET STOP MSSQL\$SQLEXPRESSPCG

After the K:\PCGSQLdb directory backup has completed – Start Services

• The following commands should be entered in the command prompt for *Windows* or added to the backup bat file to <u>start</u> the services:

#### NET START MSSQL\$SQLEXPRESSPCG

 (Make sure to wait at least 2 minutes for SQLEXPRESSPCG to start before trying to start VQueueService)

**NET START VQueueService** 

# A1.5. Remote Desktop Connection and PCGenesis Security Recommendations

The GA DOE is currently working with a security consultation company to explore how security can be improved for the PCGenesis server and data. Specifically, the GA DOE is exploring how to provide better protection against ransomware and mal-ware from infecting the PCGenesis server. After an initial consultation, the security experts advised that PCGenesis' greatest vulnerability was the way individual workstations map the **K**: drive as \\PCGServer\PCGenesis\\$. Mapping a drive to the PCGenesis server from each individual workstation may provide an access point for ransomware and mal-ware to infect the server by way of an individual user who has inadvertently downloaded a virus.

As an answer to this problem, the security consultants recommend that the PCGenesis application be accessed using a **Remote Desktop Connection**. The recommendation is to utilize **Remote Desktop Connection** instead of mapping the PCGenesis server as a drive on individual workstations. This would add a level of obfuscation and complexity that would help prevent mal-ware from infecting the PCGenesis server.

Therefore, the GA DOE highly recommends **Remote Desktop Connection** as the preferred method for all users accessing PCGenesis. **Remote Desktop Connection** has several advantages in addition to providing better protection for the PCGenesis server and data. It allows the PCGenesis application to run much faster, and because the application will continue to run even if the network connection goes down, data reliability is also improved.

### A2. Payroll System

#### A2.1. 2020 Federal Tax Withholding


A problem was reported to the PCGenesis help desk. For employees with the **Box 2-Two jobs flag** set to '**Y**', PCGenesis may <u>under-withhold their Federal Tax</u>. The **Box 2-Two jobs flag** field corresponds to the checkbox in Step 2(c) of the 2020 W-4. Step 2(c) of the 2020 W-4 reads as follows:

2(c) If there are only two jobs total, you may check this box. Do the same on Form W-4 for the other job. This option is accurate for jobs with similar pay; otherwise, more tax than necessary may be withheld

When Step 2(c) is checked, the **Box 2-Two jobs flag** field is set to '**Y**' on the *Update Payroll Withholding/Direct Deposit Data* screen in PCGenesis, and for these employees, the Federal Tax may be under-withheld. This problem is corrected with this release.

## A2.2. Payroll Trial Register - New .Csv Output File

The *Payroll Trial Register* (F2, F3, F3) procedure has been enhanced to allow the user to create a .csv output file with the information printed on the *Payroll Trial Registers*. It contains both the employer and employee deduction contributions for the current payroll, as well as the employee ID number, Social Security Number, employee name, class code, location code, net pay, gross salary, OASDI gross, HI gross, and annuity company codes, for each active employee. The .csv output file contains slots for each of the 72 possible system deduction codes even though a subset of deductions may be used at each individual school district.



### A3. Financial Accounting and Reporting (FAR) System

#### A3.1. Account Description File Converted to Database Tables

In release 20.01.00, the *Account Master Description* VISION indexed file (K:\SECOND\FARDATA\**NAME**) is converted into the following *SQL Server* database tables:

- Name 01 Fiscal Year
- Name\_02\_Fund
- Name 03 FY flag
- Name\_04\_Program
- Name\_05\_Function
- Name\_06\_Object

Any PCGenesis module that references the *Account Master Description File* has been updated to utilize the *SQL Server* tables listed above.

The Account Master Description tables represent the 10 "pieces" of the 30-digit account number. These account "pieces" correspond to the Yr Fnd F Prgm Fnct Objet Fcty B Addt'l fields of a general ledger account. The Account Master Description tables also provide the descriptions of the account number on various Financial Accounting and Reporting (FAR) system reports, and determines if the account number is valid when entered in PCGenesis.

With release 20.01.00, **K:\SECOND** must be restored with the **PCGenesisDB** database. These two entities must be kept in sync, otherwise the *Display Bank Balances* screen (F1, F8, F1) will not display correct **Bank Cash** or **Bank Invested** amounts.

#### A3.2. NAME File Transaction Processing

With release 20.01.00, the PCGenesis system has begun to add the logic for transaction processing. The programs that update either the **Bank Cash** or **Bank Invested** fields in the **FAR.Bank\_File** database table are listed below. Each of the processes listed below updates numerous PCGenesis data tables. As all the files in the PCGenesis system are converted to SQL Server database tables, transaction processing will prevent partial postings of financial data.


Today, if a posting process is interrupted because of a power failure, or network hiccup, half of the PCGenesis data files may be updated (for instance the BANK file) and half of the files may not be updated (for instance the AUDIT file). This requires a data repair!! In the future, this problem will be solved by not "committing" all the data to the database until the entire transaction is complete.

- *Update Budget Files with Vendor Check Information* (F1, F4, F5, F5)
- Enter Manual Vendor Check/Wire Transfer (F1, F4, F7)
- *Void Vendor Check/Wire Transfer* (F1, F4, F8)
- *Invest Funds* (F1, F8, F3, F1)
- Cancel Investment/Redeem Investment (F1, F8, F3, F2)
- *Add/Update General Ledger Account* (F1, F11, F2)
- *Journal Entry* (F1, F11, F5)
- Special Journal Entry (F1, F13, F30)
- *Cancel Receipt* (F1, F9, F3, F8)
- Deposit Receipt (F1, F7, F8)
- Reverse Deposit (F1, F7, F9)
- Update Budget Files with Current Pay (F2, F3, F14)

### A4. Certified/Classified Personnel Information (CPI) System

#### A4.1. CPI Rollover Processing

CPI Rollover Processing (F4, F31, F12) has been enhanced with an option to allow classified salaries to be updated. The 'Update classified salaries' option is displayed when rolling over from Cycle Three to Cycle One. When the 'Update classified salaries' field is set to 'Y', the Annual Classified Salary field on the CPI Biographical Data screen will automatically default to the employee's Contract Salary amount from the Update/Display Gross Data screen when Classified Employment Basis field is greater than zero and the Certified Employment Basis field equals zero in CPI. If the Certified Employment Basis field is greater than zero, the Annual Classified Salary field will not be updated even if the Classified Employment Basis field is also greater than zero. This will facilitate getting ready for CPI Cycle One by having almost all classified salaries updated automatically.



# Section B: Installation Instructions for Release 20.01.00 Software

# B1. Perform a PCGenesis Full Backup

Proceed to section B2. Verify Windows Security Group GENUSERS in this document if these two conditions are met:

- 1. The prior evening's full system backup was successful.
  - In addition to its current labeling, also label the prior evening's backup media as "Data Backup Prior to Release 20.01.00".
  - Continue to use the backup in the normal backup rotation.
- 2. No work has been done in PCGenesis since the prior backup.

Otherwise, continue with the instructions in section *B1. Perform a PCGenesis Full Backup* if these two conditions are <u>not</u> met.

Step	Action
1	Verify all users are logged out of PCGenesis.
2	Stop the VerraDyne Queue Service ( <b>VQueueService</b> ) and the SQL Express Service ( <b>SQLEXPRESSPCG</b> ) prior to running a full backup of the <b>K:\</b> PCGenesis disk drive or else the backup will not run to completion.
	If the <i>Uspool</i> background task has not yet been removed from the from "All Users Startup", close <i>Uspool</i> at the server. <i>Uspool</i> must be permanently removed and should no longer be running on the server.
3	Perform a PCG Full Backup to CD or DVD or USB.
4	When the PCGenesis backup completes, label the backup CD or DVD or USB "Full System Backup Prior to Release 20.01.00".
5	Start the SQL Express Service: SQLEXPRESSPCG must be running before starting the release installation. If SQL Server is not running, the PCGenesisDB cannot be updated during the release installation. If you run a full backup prior to installing the release and SQL Server has been stopped, the following commands can be executed to restart SQLEXPRESSPCG.
	<ul> <li>The following commands should be entered in the command prompt for <i>Windows</i> or added to the backup bat file to start the services.</li> <li>NET START MSSQL\$SQLEXPRESSPCG</li> </ul>
6	Proceed to B2. Verify Windows Security Group GENUSERS.

### B2. Verify Windows Security Group GENUSERS

The DOE is continuing the conversion of PCGenesis data tables into a *SQL Server* database in the 20.01.00 release.

Operating System Requirements for the PCGenesis Database

1. Prior to release 19.01.00, the PCGenesis document *New Server Installation Checklist* recommended setting up **GENUSERS** as the Windows Server security group for all PCGenesis users, but this requirement was not enforced. Please refer to *Page 2*, *Step 4* in the following document:

Starting with release 19.01.00, the security user group GENUSERS is now required.

 Please forward this notice to your IT support team and ask them to verify the setup of GENUSERS on your PCGenesis Windows Server. If GENUSERS is not the current security group for PCGenesis users, please have the IT staff set up GENUSERS as directed in the document referenced above.



#### **Important Note**


The person installing the PCGenesis release must be a member of the system administrator security group on the PCGENESIS server!

Step	Action
1	NOTE: The person installing the PCGenesis release must be a member of the system administrator security group on the PCGenesis server. This is required to properly install the <i>PCGenesisDB</i> database components contained in this release.
2	Start the SQL Express Service: SQLEXPRESSPCG must be running before starting the release installation. If SQL Server is not running, the PCGenesisDB cannot be updated during the release installation.
3	Verify all users are logged out of PCGenesis.
4	Open Windows® Explorer.
5	Navigate to the K:\INSTAL directory.
6	Verify PCGUNZIP.EXE, RELINSTL.BAT, and INSTLPCG display.
	If PCGUNZIP.EXE and RELINSTL.BAT and INSTLPCG do not display, return to the MyGaDOE Web portal, and detach the files from the Web portal again.
7	*** ALERT ***
	After downloading the files we need to make sure they are not blocked, otherwise when we unzip, ALL the files will all be blocked. This is a new security feature of the Windows Server 2012 / 2016 operating system.
	To check whether the files have been blocked, <b>right-click</b> on each of the downloaded files and select <b>Properties</b> . If you see a security message at the bottom, as shown below, you will need to click the 'Unblock' button. This is a very important step!
	For each of the downloaded files in <b>K:\INSTAL</b> , right-click on the filename and select 'Properties'.

After right-clicking on each file, select the 'Properties' option:



Depending on the version of the Windows operating system, the following screen displays:





# Section C: After PCGenesis Release 20.01.00 Has Been Installed

## C1. Verify Contents of the End-of-February Backup

This step is very, very important! The PCGenesis development team wants to ensure that all school districts are creating a backup of the PCGenesis data, including the contents of the **PCGSQLdb** database directories as well as the **SECOND** data. Our concern is that school districts do not have a good backup of the <u>database</u> data, in which case you may not realize that you have an incomplete backup and *a critical problem*. School districts are under increasing pressure from hackers and malware attacks and therefore, it is nothing short of imperative that you can recover your PCGenesis data in case of an attack, or other data center catastrophe. To that end, please follow the steps below.
